## About this republication

### The republished law

This is a republication of the *Animal Diseases (Bees) Regulation 2000* (repealed), made under the *Animal Diseases Act 1993*, including any amendment made under the *Legislation Act 2001*, part 11.3 (Editorial changes). It also includes any commencement, amendment, repeal or expiry affecting the republished law to 14 October 2005.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

### Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at [www.legislation.act.gov.au](http://www.legislation.act.gov.au)):

- authorised republications to which the *Legislation Act 2001* applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

### Editorial changes

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication does not include amendments made under part 11.3 (see endnote 1).

### Uncommenced provisions and amendments

If a provision of the republished law has not commenced or is affected by an uncommenced amendment, the symbol **U** appears immediately before the provision heading. The text of the uncommenced provision or amendment appears only in the last endnote.

### Modifications

If a provision of the republished law is affected by a current modification, the symbol **M** appears immediately before the provision heading. The text of the modifying provision appears in the endnotes. For the legal status of modifications, see *Legislation Act 2001*, section 95.

### Penalties

The value of a penalty unit for an offence against this republished law at the republication date is—

- (a) if the person charged is an individual—\$100; or
- (b) if the person charged is a corporation—\$500.

**1 Name of regulation**

This regulation is the *Animal Diseases (Bees) Regulation 2000*.

**3 Definitions for regulation**

In this regulation:

*Note* A definition applies except so far as the contrary intention appears (see Legislation Act, s 155).

**broodbox** means the bottom box of an active beehive.

**frame hive** means a beehive that—

- (a) contains only moveable frames that can be readily and separately removed for examination; or
- (b) contains—
  - (i) fixed frames in all honey super-boxes of the beehive; and
  - (ii) only moveable frames, that can be readily and separately removed for examination, in the broodbox of the beehive; and
  - (iii) a device fitted immediately above the broodbox of the beehive that excludes the queen bee from all honey super-boxes of the beehive.

**honey super-box** means an upper box of a beehive in which honey is stored.

**4 Honey bees to be kept in frame hives**

A person must not keep honey bees other than in a frame hive.

Maximum penalty: 10 penalty units.

**5 Honey not to be exposed**

A person must not expose honey or honeycomb, other than in a frame hive, in a way that honey bees may have access to it.

Maximum penalty: 10 penalty units.

### 1 About the endnotes

Amending and modifying laws are annotated in the legislation history and the amendment history. Current modifications are not included in the republished law but are set out in the endnotes.

Not all editorial amendments made under the *Legislation Act 2001*, part 11.3 are annotated in the amendment history. Full details of any amendments can be obtained from the Parliamentary Counsel's Office.

Uncommenced amending laws and expiries are listed in the legislation history and the amendment history. These details are underlined. Uncommenced provisions and amendments are not included in the republished law but are set out in the last endnote.

If all the provisions of the law have been renumbered, a table of renumbered provisions gives details of previous and current numbering.

The endnotes also include a table of earlier republications.
