About this republication

The republished law

This is a republication of the *Building and Construction Industry Training Levy Regulations* 2001, made under the *Building and Construction Industry Training Levy Act* 1999 (including any amendment made under the *Legislation Act* 2001, part 11.3 (Editorial changes)) as in force on 1 July 2004. It also includes any amendment, repeal or expiry affecting the republished law to 1 July 2004.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the *Legislation Act 2001* applies

Editorial changes

The Legislation Act 2001, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see Legislation Act 2001, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication does not include amendments made under part 11.3 (see endnote 1).

Uncommenced provisions and amendments

If a provision of the republished law has not commenced or is affected by an uncommenced amendment, the symbol **U** appears immediately before the provision heading. The text of the uncommenced provision or amendment appears only in the last endnote.

Modifications

If a provision of the republished law is affected by a current modification, the symbol **M** appears immediately before the provision heading. The text of the modifying provision appears in the endnotes. For the legal status of modifications, see *Legislation Act 2001*, section 95.

Penalties

The value of a penalty unit for an offence against this republished law at the republication date is...

1 Name of regulations

These regulations are the Building and Construction Industry Training Levy Regulations 2001.

3 Qualified valuer—Act, s 15, def qualified valuer

- (1) A qualified valuer is a person who is—
 - (a) an accredited valuer; or
 - (b) an architect registered under the Architects Act 2004 or a corresponding State law; or

State is defined in the Legislation Act, dict, pt 1. Note

- (c) an engineer who is registered on the National Professional Engineers Register administered by The Institution of Engineers, Australia in any of the following general areas of practice:
 - (i) building services;
 - (ii) civil;
 - (iii) electrical;
 - (iv) structural; or
- (d) a quantity surveyor who is a corporate member of The Australian Institute of Quantity Surveyors.
- (2) In this regulation:

accredited valuer means a person who is—

- (a) registered, licensed or approved under a Commonwealth or State law to carry out valuations of property; or
- (b) accredited as a certified practising valuer by the Australian Property Institute Incorporated.
