### About this republication

#### The republished law

This is a republication of the *Stock Regulation 2005*, made under the *Stock Act 2005* (including any amendment made under the *Legislation Act 2001*, part 11.3 (Editorial changes)) as in force on 26 August 2005. It also includes any commencement, repeal or expiry affecting the republished law.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

#### Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the *Legislation Act 2001* applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

#### **Editorial amendments**

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication does not include amendments made under part 11.3 (see endnote 1).

#### **Uncommenced provisions and amendments**

If a provision of the republished law has not commenced or is affected by an uncommenced amendment, the symbol  $\boxed{\mathbf{U}}$  appears immediately before the provision heading. The text of the uncommenced provision or amendment appears only in the last endnote.

#### **Modifications**

If a provision of the republished law is affected by a current modification, the symbol **M** appears immediately before the provision heading. The text of the modifying provision appears in the endnotes. For the legal status of modifications, see *Legislation Act* 2001, section 95.

#### **Penalties**

The value of a penalty unit for an offence against this republished law at the republication date is—

- (a) if the person charged is an individual—\$100; or
- (b) if the person charged is a corporation—\$500.

## 1 Name of regulation

This regulation is the Stock Regulation 2005.

#### 3 Notes

A note included in this regulation is explanatory and is not part of this regulation.

Note See the Legislation Act, s 127 (1), (4) and (5) for the legal status of notes.

## 4 Minimum stock levy—Act, s 8 (4), def *minimum stock levy*

- (1) The minimum stock levy is—
  - (a) for a small landholding—nil; or
  - (b) in any other case—\$40.
- (2) In this section:

#### small landholding means—

- (a) land of less than 10 hectares; or
- (b) land that has a stock-carrying capacity of less than 50, worked out using a standard dry sheep equivalent measure based on a 50kg merino wether.

## 5 Placement of permanent brands—Act, s 26

- (1) A permanent brand may be placed on a horse in the following places:
  - (a) near-shoulder;
  - (b) off-shoulder;
  - (c) near-rump, hip and thigh;
  - (d) off-rump, hip;
  - (e) near-ribs and saddle;

- (f) off-ribs and saddle.
- (2) A permanent brand may be placed on large stock, other than horses, in the following places:
  - (a) near-rump, hip or thigh;
  - (b) off-rump, hip or thigh;
  - (c) near-back and ribs;
  - (d) off-back and ribs;
  - (e) near-shoulder;
  - (f) off-shoulder;
  - (g) near-loin;
  - (h) off-loin.

#### 1 About the endnotes

Amending and modifying laws are annotated in the legislation history and the amendment history. Current modifications are not included in the republished law but are set out in the endnotes.

Not all editorial amendments made under the *Legislation Act 2001*, part 11.3 are annotated in the amendment history. Full details of any amendments can be obtained from the Parliamentary Counsel's Office.

Uncommenced amending laws and expiries are listed in the legislation history and the amendment history. These details are underlined. Uncommenced provisions and amendments are not included in the republished law but are set out in the last endnote.

If all the provisions of the law have been renumbered, a table of renumbered provisions gives details of previous and current numbering.

The endnotes also include a table of earlier republications.
