### Part 1 Preliminary

#### 1 Name of regulation

This regulation is the Road Transport Legislation Amendment Regulation 2011 (No 1).

#### 2 Commencement

This regulation commences on the day after its notification day.

*Note* The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

#### 3 Legislation amended

This regulation amends the following legislation:

- Road Transport (Public Passenger Services) Regulation 2002
- Road Transport (Safety and Traffic Management)
  Regulation 2000
- Road Transport (Vehicle Registration) Regulation 2000.

## Part 2 Road Transport (Public Passenger Services) Regulation 2002

#### 4 Section 8 (1)

substitute

- (1) The road transport authority must refuse an application for accreditation (including renewal) if—
  - (a) the applicant is not an Australian citizen or permanent resident; or
  - (b) the authority believes on reasonable grounds that—
    - (i) the applicant is not a suitable person to operate the kind or size of regulated service to which the application relates; or
    - (ii) the applicant does not have the capacity to meet the applicant's proposed service standards; or
    - (iii) the proposed service standards do not adequately state how the applicant will comply with the approved minimum service standards for the regulated service to which the application relates; or
    - (iv) compliance by the applicant with the proposed service standards will not ensure that the applicant will provide a safe, reliable and efficient regulated service.

### Part 4 Road Transport (Vehicle Registration) Regulation 2000

#### 11 Section 83 (3)

substitute

- (3) The applicant must, with the application, give the road transport authority a statement, signed by the registered operator or agent, that—
  - (a) the vehicle's registration label has been destroyed; or
  - (b) the applicant will destroy the label as soon as practicable, but not later than 2 days after the applicant gives the authority the statement; or
  - (c) the applicant is unable to destroy the label, and the reason the applicant is unable to destroy it.
