#### About this republication

#### The republished law

This is a republication of the *Crimes* (Surveillance Devices) Regulation 2017, made under the Crimes (Surveillance Devices) Act 2010 (including any amendment made under the Legislation Act 2001, part 11.3 (Editorial changes)) as in force on 28 January 2022. It also includes any commencement, amendment, repeal or expiry affecting this republished law to 28 January 2022.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

#### Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the Legislation Act 2001 applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

#### **Editorial changes**

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication includes amendments made under part 11.3 (see endnote 1).

#### **Uncommenced provisions and amendments**

If a provision of the republished law has not commenced, the symbol  $\bigcup$  appears immediately before the provision heading. Any uncommenced amendments that affect this republished law are accessible on the ACT legislation register (www.legislation.act.gov.au). For more information, see the home page for this law on the register.

#### **Modifications**

#### **Penalties**

At the republication date, the value of a penalty unit for an offence against this law is \$160 for an individual and \$810 for a corporation (see *Legislation Act 2001*, s 133).

#### 1 Name of regulation

This regulation is the *Crimes* (Surveillance Devices) Regulation 2017.

#### 3 Corresponding law—Act, dict, def corresponding law

- (1) The following laws are declared to correspond to the Act:
  - (a) the Surveillance Devices Act 2007 (NSW);
  - (b) the Surveillance Devices Act 1999 (Vic);
  - (c) the *Police Powers and Responsibilities Act 2000* (Qld), chapter 13;
  - (d) the *Police Powers (Surveillance Devices) Act* 2006 (Tas);
  - (e) the Surveillance Devices Act 2007 (NT);
  - (f) the *Surveillance Devices Act 2016* (SA), except to the extent that it provides for a surveillance device (emergency) authority to be granted in relation to a serious drug offence.

Note A surveillance device (emergency) authority would otherwise be a corresponding emergency authorisation (see Act, dict, def *corresponding emergency authorisation*).

#### (2) In this section:

*serious drug offence*—see the *Surveillance Devices Act 2016* (SA), section 3.

surveillance device (emergency) authority—see the Surveillance Devices Act 2016 (SA), section 3.
