## Statute Law Revision (Penalties) Bill 1998

---

### A BILL

FOR

### An Act to revise the statute law of the Territory in relation to penalties

The Legislative Assembly for the Australian Capital Territory enacts as follows:

**1. Short title**

5 This Act may be cited as the *Statute Law Revision (Penalties) Act 1998*.

**2. Commencement**

(1) Section 1 and this section commence on the day on which this Act is notified in the *Gazette*.

10 (2) Section 3 commences on a day, or respective days, fixed by the Minister by notice in the *Gazette*.

(3) If section 3 has not commenced before the end of the period of 6 months commencing on the day on which this Act is notified in the *Gazette*, that provision, by force of this subsection, commences on the first day after the end of that period.
