### REVOCATION AND DETERMINATION OF FEES

#### INSTRUMENT No. 147 OF 2001

1. Pursuant to section 27B of the **Hawkers Act 1936** (the Act) I **REVOKE** the Determination No 159 of 2000 dated 22 May 2000 notified in Gazette No S20 of 8 June 2000 and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.
