AN ORDINANCE

To amend the Registration of Births, Deaths and Marriages Ordinance 1929-1944.

BE it ordained by the Administrator of the Government of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *Seat of Government Acceptance Act 1909-1938* and the *Seat of Government (Administration) Act 1910-1947*, as follows:—

1.—(1.) This Ordinance may be cited as the *Registration of Births, Deaths and Marriages Ordinance 1951*.^{*} Short title and citation.

(2.) The *Registration of Births, Deaths and Marriages Ordinance 1929-1944* is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Registration of Births, Deaths and Marriages Ordinance 1929-1950*.

2. After section twenty-three of the Principal Ordinance the following section is inserted:—

“23A.—(1.) Where the death of a person is reported to a Coroner and the Coroner is satisfied that there is no reason why the body should not be cremated, he may, upon a request being made to him by a relative of the deceased, by the executor of the will of the deceased or by the administrator of the estate of the deceased, grant a certificate in accordance with the form in the Eighteenth Schedule. Coroner's certificate permitting cremation.

“(2.) A Coroner shall not grant a certificate under this section unless he is satisfied that the facts of the case justify him in so doing.”

3. After the Seventeenth Schedule to the Principal Ordinance the following Schedule is added:— Eighteenth Schedule.
