## About this republication

### The republished law

This is a republication of the *Drugs of Dependence Regulation 1993*, made under the *Drugs of Dependence Act 1989* (including any amendment made under the *Legislation Act 2001*, part 11.3 (Editorial changes)) as in force on 2 November 2004. It also includes any amendment, repeal or expiry affecting the republished law to 2 November 2004.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

### Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at [www.legislation.act.gov.au](http://www.legislation.act.gov.au)):

- authorised republications to which the *Legislation Act 2001* applies

### Editorial changes

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication includes amendments made under part 11.3 (see endnote 1).

### Uncommenced provisions and amendments

If a provision of the republished law has not commenced or is affected by an uncommenced amendment, the symbol **U** appears immediately before the provision heading. The text of the uncommenced provision or amendment appears only in the last endnote.

### Modifications

If a provision of the republished law is affected by a current modification, the symbol **M** appears immediately before the provision heading. The text of the modifying provision appears in the endnotes. For the legal status of modifications, see *Legislation Act 2001*, section 95.

### Penalties

The value of a penalty unit for an offence against this republished law at the republication date is—

- (a) if the person charged is an individual—\$100; or
- (b) if the person charged is a corporation—\$500.

**1 Name of regulation**

This regulation is the *Drugs of Dependence Regulation 1993*.

**4 Drugs of dependence for Act, pt 2**

For the Act, section 4, definition of *drug of dependence*, the substances specified in schedule 3 are prescribed.

**5 Commercial quantities**

For the Act, section 160 (1), definition of *commercial quantity*—

- (a) the prescribed quantity of a drug of dependence specified in schedule 1, column 2 is the quantity specified in the appropriate column or columns of schedule 1 opposite the reference to that drug; and
- (b) the prescribed quantity of a prohibited substance specified in schedule 2, column 2 is the quantity specified in the appropriate column or columns of schedule 2 opposite the reference to that substance.

**6 Traffickable quantities**

For the Act, section 160 (1), definition of *traffickable quantity*—

- (a) the prescribed quantity of a drug of dependence specified in schedule 1, column 2 is the quantity specified in the appropriate column or columns of schedule 1 opposite the reference to that drug; and
- (b) the prescribed quantity of a prohibited substance specified in schedule 2, column 2 is the quantity specified in the appropriate column or columns of schedule 2 opposite the reference to that substance.
