### SEWERAGE RATES ORDINANCE 1972

1.—(1.) This Ordinance may be cited as the *Sewerage Rates Ordinance 1972*.<sup>\*</sup>

Short title  
and citation.

(2.) The *Sewerage Rates Ordinance 1968-1970*<sup>†</sup> is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Sewerage Rates Ordinance 1968-1972*.

2. Section 2 of the Principal Ordinance is repealed and the following section inserted in its stead:—

“2. On and after the first day of July, One thousand nine hundred and seventy-two, this Ordinance applies to and in relation to the rating year that commenced on the first day of July, One thousand nine hundred and seventy-two, and to each subsequent rating year.”
