About this republication

The republished law

This is a republication of the *Registrar-General Act 1993* (including any amendment made under the *Legislation Act 2001*, part 11.3 (Editorial changes)) as in force on 12 April 2007. It also includes any amendment, repeal or expiry affecting the republished law to 12 April 2007.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the Legislation Act 2001 applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

Editorial changes

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication does not include amendments made under part 11.3 (see endnote 1).

Uncommenced provisions and amendments

If a provision of the republished law has not commenced or is affected by an uncommenced amendment, the symbol \boxed{U} appears immediately before the provision heading. The text of the uncommenced provision or amendment appears only in the last endnote.

Modifications

If a provision of the republished law is affected by a current modification, the symbol \mathbf{M} appears immediately before the provision heading. The text of the modifying provision appears in the endnotes. For the legal status of modifications, see *Legislation Act 2001*, section 95.

Penalties

The value of a penalty unit for an offence against this republished law at the republication date is—

- (a) if the person charged is an individual—\$100; or
- (b) if the person charged is a corporation—\$500.

Registrar-General Act 1993

An Act to establish an office of registrar-general

1 Name of Act

This Act is the Registrar-General Act 1993.

2 Dictionary

The dictionary at the end of this Act is part of this Act.

- *Note 1* The dictionary at the end of this Act defines certain terms used in this Act.
- *Note* 2 A definition in the dictionary applies to the entire Act unless the definition, or another provision of the Act, provides otherwise or the contrary intention otherwise appears (see Legislation Act, s 155 and s 156 (1)).

3 Notes

A note included in this Act is explanatory and is not part of this Act.

Note See the Legislation Act, s 127 (1), (4) and (5) for the legal status of notes.

4 Registrar-General

- (1) The chief executive must appoint a public servant as the Registrar-General.
 - *Note 1* For the making of appointments (including acting appointments), see the Legislation Act, pt 19.3.
 - *Note 2* In particular, an appointment may be made by naming a person or nominating the occupant of a position (see Legislation Act, s 207).
- (2) The registrar-general has the functions given to the registrar-general by any law in force in the ACT.
- (3) Until the chief executive makes an appointment under subsection (1), the registrar-general is the public servant for the time being exercising the duties of the public service office the duties of which include exercising the functions of the registrar-general.

- (4) Subsection (3) is a law to which the Legislation Act, section 88 (Repeal does not end effect of transitional laws etc) applies.
- (5) Subsections (3) and (4) and this subsection expire 1 year after the day this section commences.

4A Deputy Registrars-General

- (1) The chief executive may appoint a public servant as a Deputy Registrar-General.
- (2) A deputy registrar-general may exercise any function of the registrar, subject to any direction of the registrar-general.
- (3) A function of the registrar-general, when exercised by a deputy registrar-general, is taken to have been exercised by the registrar-general.
- (4) Until the chief executive makes an appointment under subsection (1), a deputy registrar-general is a public servant for the time being exercising the duties of a public service office the duties of which include exercising the functions of a deputy registrar-general.
- (5) Subsection (4) is a law to which the Legislation Act, section 88 (Repeal does not end effect of transitional laws etc) applies.
- (6) Subsections (4) and (5) and this subsection expire 1 year after the day this section commences.

5 Registrar-general a corporation sole

- (1) The registrar-general—
 - (a) is a corporation sole by the name of the Registrar-General of the Australian Capital Territory; and
 - (b) has perpetual succession; and
 - (c) must have an official seal; and

- (d) is capable, in the corporate name of the registrar-general, of acquiring, holding and disposing of real and personal property and suing and being sued.
- (2) The Minister must, in writing, approve the design of the official seal.
- (3) An approval under subsection (2) is a notifiable instrument.

Note A notifiable instrument must be notified under the *Legislation Act 2001*.

No enquiry required about deputy registrar-general's compliance with directions

A person dealing with a deputy registrar-general is not bound to enquire whether the deputy registrar-general, in exercising a function in relation to the dealing—

- (a) was subject to a direction of the registrar-general; or
- (b) complied with a direction of the registrar-general to which the deputy registrar-general was subject.

Liability of registrar-general and other officers

- (1) A person who exercises, or has exercised, the functions of the registrar-general or a deputy registrar-general is not personally liable to an action or other proceeding in relation to an act or omission done honestly in the exercise or purported exercise of the function.
- (2) Where, by act or omission of the registrar-general, a person sustains a loss or injury that would have entitled that person to a remedy in respect of the loss or injury if the act or omission were an act or omission of a natural person—
 - (a) the person sustaining the loss or injury is entitled to the same remedy against the registrar-general in the corporate capacity of the registrar-general as the person would have been entitled to against a natural person; and

(b) the liability of the registrar-general must be discharged by the Territory.

9 Invalidity of documents

A document is not invalid on the ground that there was-

- (a) an informality in connection with the affixing of the seal; or
- (b) a failure to affix the seal.
