Real Property (Consequential Provisions) Act 1993

No. 90 of 1993

An Act to amend certain Acts consequent on the *Real Property (Amendment) Act 1993* and for related purposes

[Notified in ACT Gazette S258: 17 December 1993]

The Legislative Assembly for the Australian Capital Territory enacts as follows:

Short title

1. This Act may be cited as the *Real Property (Consequential Provisions) Act 1993.*

Commencement

- **2.** (1) Section 1 and this section commence on the day on which this Act is notified in the *Gazette*.
- (2) Section 3 commences on the day fixed under subsection 2 (2) of the *Real Property (Amendment) Act 1993*.
