## **Remuneration Tribunal (Consequential and Transitional Provisions) Act 1995**

**An Act to amend certain laws and to make certain transitional arrangements in consequence of the enactment of the *Remuneration Tribunal Act 1995***

*[Notified in ACT Gazette S313: 20 December 1995]*

The Legislative Assembly for the Australian Capital Territory enacts as follows:

### **Short title**

1. This Act may be cited as the *Remuneration Tribunal (Consequential and Transitional Provisions) Act 1995*.

### **Commencement**

2. This Act commences on the day fixed for the purposes of subsection 2 (2) of the *Remuneration Tribunal Act 1995*.

### **Continuation of previous determinations**

3. (1) In this section—

“commencement day” means the day fixed for the purposes of subsection 2 (2) of the *Remuneration Tribunal Act 1995*;

“Commonwealth Remuneration Tribunal” means the tribunal established by subsection 4 (1) of the *Remuneration Tribunal Act 1973* of the Commonwealth.

(2) Where, immediately before the commencement day, a determination of the Commonwealth Remuneration Tribunal applied to a person referred to

in section 9 or 10 of the *Remuneration Tribunal Act 1995*, that person shall continue to be entitled to be paid remuneration and allowances, and to be granted other entitlements, in accordance with that determination until a determination is made under that Act in respect of the remuneration, allowances and entitlements of the person.

### **Amendments of Acts**
