An Act to amend the Emergencies Act 2004

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1		Name of Act
		This Act is the Emergencies (Commissioner Directions) Amendment Act 2012.
2		Commencement
		This Act commences on the day after its notification day.
		<i>Note</i> The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).
3		Legislation amended
		This Act amends the <i>Emergencies Act 2004</i> .
4		Emergency services commissioner New section 7 (2)

	(2)	However, the director-general may appoint a person under subsection (1) only if the person has the management, professional and technical expertise to exercise the commissioner's functions.

*Note 2* The commissioner may direct a chief officer to undertake response or recovery operations in relation to an emergency (see s 8A).

#### 8A Directions by commissioner in relation to emergencies

(1) This section applies to an emergency other than one for which an emergency controller is appointed.

- (2) The commissioner may direct a chief officer to undertake response or recovery operations in relation to the emergency.
- (3) The commissioner may not direct the chief officer to undertake an operation in a particular way.

### 7 Delegation by commissioner New section 12 (2)

(2) However, the commissioner may delegate the commissioner's power under section 8A only to a chief officer.
