#### SCHEDULE OF NOTES

- 1. This form is to be used only for a transfer of mortgage. A transfer of mortgage is registered by making a note on the relevant folio of the register. The certificate of title is not required.
- 2. Documents must be typed, or completed in black ink or biro.
- Alterations to information entered on the form should be made by crossing out (not erasing or obliterating by painting over) and should be initialled by the parties.
- If there is insufficient space in any panel use an annexure sheet. 5.
- 6. Volume and Folio references must be given.
- 7. Provide details of the mortgage number.
- 8. Provide full names of the transferor who is undertaking the transfer, including the estate or interest transferred.
- 9. Provide full names of the transferee, including their postal address.
- 10. Provide the form of tenancy (joint tenants or tenants in common)
- 11. Provide the consideration (sale price, deed, court order or by statute).
- 12. Execution by
  - A Natural Person Should be witnessed by an adult person who is not a party to the document.
  - Attorney if this document is executed by an Attorney pursuant to a registered power of attorney, it must set out the full name of the attorney and the form of execution must indicate the source of his/her authority eg. "AB by his/her attorney XY pursuant to Power of Attorney ACT Registration No..... of which he/she has no notice of revocation".
  - Corporation Section 127 of the Corporations Act provides that a company may now validly execute a document with or without using a Common Seal if the document is signed by:
    - a. Two directors of the company;
    - b. A director and a secretary of the company; or
    - c. Where the company is a proprietary company and has a sole director who is also the sole company secretary, that
