- 6. For refunds made by EFT please ensure that you provide the correct details as follows:
  - the best place to obtain your Bank, BSB and Account Numbers is from your bank statement.
  - your Bank and BSB numbers relate to the bank and branch where you originally opened your account.
  - your account number is NOT the number imprinted on your plastic account card.
