This form is to be used to lodge an occupancy bond under the Residential Tenancies Act 1997 (the Act). You can access the Act at www.legislation.act.gov.au. You may also obtain further information and forms at www.ors.act.gov.au.

Are you paying land tax on this rental property? If the answer is no, you will need to advise the Commissioner for ACT Revenue as land tax can apply to any ACT residential property that is rented. Visit the ACT Revenue Office web site at www.revenue.act.gov.au/land tax.

PRIVACY INFORMATION

The Act authorises the collection of the information required by this form. Any unreasonable intrusion into a person's privacy in accordance with the Privacy Act 1988 (C'wlth) will be prevented. However, identifiable information is provided to law enforcement organisations and authorised organisations that have legal authority to request information under prescribed circumstances. Information may also be released to the Commissioner of Social Housing where a Housing ACT bond loan exists over the bond. Non-identifying information is regularly released to the Real Estate Institute of Australia.

INSTRUCTIONS FOR COMPLETION

- If completing this form by hand please use a black pen only.
- This office will not accept lodgement of this form if it is not completed in full.
- Any alteration to information provided on this form must be struck through with a black pen. Substitute information must be clear and all parties must sign in the margin. Do not use correction fluid or tape.
- The total amount of bond must not exceed the sum of four weeks rent. Monthly rental amounts are not permitted for the purposes of determining the amount of bond to be lodged. It is the responsibility of the grantor/s to provide a receipt/s to the occupant/s upon the payment of bond money.
- Bonds relating to occupancy agreements may be lodged with this office.
- Only persons that have contributed to the bond should be noted as occupants. Children of the occupants or any other person that does not contribute to the payment of the bond should not be noted on this form.
- All persons referred to on this form must sign in the relevant section. Failure to sign may result in delays when applying for a refund of bond money.
- If a company or embassy is paying for the bond on behalf of the occupant/s, the company or embassy should be noted as the occupant for the purposes of lodging the bond.
- Bonds paid by personal cheque will not be refunded less than 30 days after the date of lodgement.
- All cheques and money orders should be made payable to Rental Bonds.
- Please note bond money will be divided equally among the occupants noted on this form upon lodgement of a validly completed refund of bond form. If the occupants do not wish the bond to be refunded in equal amounts, a written statement signed by all occupants must accompany the refund of bond form indicating the amount to be refunded to each occupant.
