# ACT HERITAGE REGISTER— Request for approval to publish restricted information Heritage Act 2004, s56

The ACT Heritage Register contains details of places and objects of significance to the ACT.

This form may be used to request approval to publish restricted information under the *Heritage Act 2004*. In some instances the ACT Heritage Council can declare particular information to be restricted if satisfied, on reasonable grounds, that public disclosure of the information would be likely to have a substantial adverse effect on the heritage significance of a place or object, or to an Aboriginal place or object. It is an offence to knowingly publish this information without formal approval.

The ACT Heritage Council is under no obligation to approve the publishing of restricted information and may not do so if it considers it possible that by doing so there may be a substantial adverse effect on the heritage significance of the place or object, or on the Aboriginal place or object.

A fee is payable on receipt of this form. Additional charges may apply where the request relates to a large area. A schedule of fees is available on the ACT Heritage website at <a href="https://www.environment.act.gov.au/heritage">www.environment.act.gov.au/heritage</a>.

This form is not required for access to and/or to publish restricted information if the request:

- a) is made by a person with a traditional affiliation with the place or object AND
- b) the information:
  - will be given to another Aboriginal person OR
  - will be used for the purpose of education about Aboriginal tradition OR
  - is necessary and reasonable to avoid an imminent risk of damage to, or destruction of, an Aboriginal place or object.

In these instances, this form is optional and no fees apply.
