ACT HERITAGE REGISTER— Request for limited access to restricted information Heritage Act 2004, s57

The ACT Heritage Register contains details of places and objects of significance to the ACT.

This form may be used to request access to restricted information under s.57 of the *Heritage Act 2004* (the Act). Under s.54 of the Act, the ACT Heritage Council (the Council) can declare particular information to be restricted if satisfied, on reasonable grounds, that public disclosure of the information would be likely to have a substantial adverse effect on the heritage significance of a place or object, or to an Aboriginal place or object.

A person may apply for access to restricted information under s.57 if:

- (a) The land is offered for sale; and
- (b) An interested person for the land, or someone considering buying an interest in the land, applies to the Council for access to restricted information relevant to the conservation and use of the land.

In these circumstances, the Council must give access to the applicant for restricted information, together with a written explanation about the operation of Part 9 of the Act.

Where the Council has given limited access to restricted information the information is not to be made available for the general public or an audience broader than that described in the Council's advice.

Please note that a separate application must be made, in accordance with s.56 of the Act, to seek approval to publish restricted information.

A fee is not required for lodgement of this form.
