- This office will not accept lodgement of this form if it is not completed in full.
- Any alteration to information provided on this form must be struck through with a black pen. Substitute information must be clear, and all parties must sign in the margin. Do not use correction fluid or tape.
- Ensure all required documents are attached.

### **REQUIRED DOCUMENTS**

- The certificate of title or production of title consenting to the registration of this document is required for lodgement.
- Evidence of how the name was changed original or certified copy e.g.: Marriage Certificate (Ceremonial Certificate is not acceptable) or Change of Name Certificate
- Primary Identification Original or Certified Copy of Birth Certificate, Citizenship Certificate or Passport

In Person:

- Secondary Identification Original or Certified Copy of Drivers Licence, Medicare Card, Pension Card or Tax File Number Declaration issued by the Australian Taxation Office
- At least one form of identification accompanying the application form (either primary or secondary) is required to be photographic and in the registered proprietor's new name.
- The combination of identifications that are acceptable are:
  - Two Primary
  - One Primary and One Secondary
- Two forms of secondary identification will <u>NOT</u> be accepted
- Foreign identification will not be accepted unless it has been translated to English. Refer Chapter 2 of the Land Titles Practice Manual for further information.
