Obligations

A broadcaster is required to submit a return if an electoral advertisement was broadcast during the pre-election period with the authority of a participant, or participants, in the election.

"Broadcast" includes broadcast by radio or television. "Broadcaster" means the: Australian Broadcasting Corporation; Special Broadcasting Service Corporation; Holder of a licence under the Broadcasting Services ACT 1992 of the Commonwealth; or Provider of a broadcasting service under a class licence under the Act.

The return is to include electoral advertisements placed on behalf of special interest groups (such as third-party campaigners) as well as those on behalf of political parties, MLAs and candidates participants. You are only required to report one transaction per entity that has placed the electoral advertisements.

A separate return form must be completed for each television and radio station owned by the business including electronic publications. A consolidated return for the broadcasting group as a whole cannot be accepted. Where charges for advertisements are made on a group basis, these must be apportioned to each station within the group.
