## Law Reform (Repeal of Laws) Bill 1997

### A BILL

FOR

### An Act to repeal certain laws

The Legislative Assembly for the Australian Capital Territory enacts as follows:

#### Short title

- 5       1. This Act may be cited as the *Law Reform (Repeal of Laws) Act 1997*.

#### Commencement

2. This Act commences on the day on which it is notified in the *Gazette*.

#### Repeal of Acts

- 10       3. The Acts specified in Schedule 1 are repealed.

#### Repeal of applied NSW laws

4. The laws specified in Schedule 2, being Acts of the Parliament of New South Wales which apply in the Territory by force of subsection 34 (4)
