# **Animal Welfare Amendment Bill 2006**

## A Bill for

An Act to amend the Animal Welfare Act 1992, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

2		This Act is the Animal Welfare Amendment Act 2006.
3	2	Commencement
4		This Act commences on the day after its notification day.
5 6		<i>Note</i> The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

13			(a) endangers, or is likely to endanger, the animal's life; or
14			(b) is, or is likely to be, significant and longstanding.
15	7B		Alternative verdicts—cruelty
16 17 18 19 20		(1)	This section applies if, in a prosecution for an offence against section 7A (Aggravated cruelty), the trier of fact is not satisfied that the defendant committed the offence, but is satisfied beyond reasonable doubt that the defendant committed an offence against section 7 (Cruelty).
21 22 23		(2)	The trier of fact may find the defendant guilty of the offence against section 7, but only if the defendant has been given procedural fairness in relation to that finding of guilt.
