Food Amendment Bill 2011

A Bill for

An Act to amend the *Food Act 2001*, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **1 Name of Act**

2 This Act is the *Food Amendment Act 2011*.

3 **2 Commencement**

4 (1) The following provisions commence on the day after this Act's
5 notification day:

- 6 • sections 3 to 6
7 • sections 8 to 10
8 • section 13
9 • schedule 1
10 • schedule 2, part 2.2.

11 *Note* The naming and commencement provisions automatically commence on
12 the notification day (see Legislation Act, s 75 (1)).

13 (2) Schedule 2, part 2.1 commences on the commencement of the *Food*
14 (*Nutritional Information*) *Amendment Act 2011*, section 4.

15 (3) The remaining provisions commence on a day fixed by the Minister
16 by written notice.

17 *Note* A single day or time may be fixed, or different days or times may be
18 fixed, for the commencement of different provisions (see Legislation
19 Act, s 77 (1)).

20 (4) However, if a provision of this Act mentioned in subsection (3) has
21 not commenced within 18 months beginning on the notification day,
22 it automatically commences on the first day after that period.

23 (5) The Legislation Act, section 79 (Automatic commencement of
24 postponed law) does not apply to this Act.

3 Legislation amended

This Act amends the *Food Act 2001*.

Note This Act also amends the following legislation (see sch 2):

- *Food (Nutritional Information) Amendment Act 2011*
- *Magistrates Court (Food Infringement Notices) Regulation 2005*.

4 New sections 84A to 84C

84A Display of closure notices

(1) This section applies if a prohibition order—

- (a) is served on the proprietor of a food business; and
- (b) directs the proprietor not to use particular premises of the business for—
 - (i) the sale of food; or
 - (ii) the handling of, or doing of any other thing to, food intended for sale.

(2) A notice (a *closure notice*)—

- (a) must be placed at each public entrance to the premises of the food business by an authorised officer as soon as practicable after the prohibition order is served on the proprietor of the business; and
- (b) may be removed only if—
 - (i) a clearance certificate is issued for the prohibition order to which the notice relates; or
 - (ii) an authorised officer removes the notice to reposition, update or correct the notice.

1 **84B Contents of closure notices**

2 A closure notice displayed at the premises of a food business must
3 contain the following information:

- 4 (a) the name and address of the business;
- 5 (b) a statement that the business is subject to a prohibition order
6 under this Act;
- 7 (c) the date the order was made;
- 8 (d) that it is an offence to interfere with the display or contents of
9 the notice;
- 10 (e) the words ‘ACT Government’ and ‘Health Directorate’ at the
11 head of the notice;
- 12 (f) any other information the chief health officer considers
13 appropriate to include.

14 **84C Interference with closure notice**

- 15 (1) A person commits an offence if—
- 16 (a) a closure notice is placed at the premises of a food business by
17 an authorised officer; and
- 18 (b) the person engages in conduct that results in the notice being
19 moved from where it was placed by the authorised officer; and
- 20 (c) the person is reckless about whether the notice would be
21 moved from where it was placed

22 Maximum penalty: 100 penalty units.

- 23 (2) A person commits an offence if—
- 24 (a) a closure notice is placed at the premises of a food business by
25 an authorised officer; and
- 26 (b) the person engages in conduct that results in any part of the
27 notice being obscured or defaced; and

1 (c) the person is reckless about whether the notice would be
2 obscured or defaced.

3 Maximum penalty: 100 penalty units.

6 **87 Contravention of improvement notices and prohibition**
7 **orders**

8 (1) The proprietor of a food business commits an offence if the
9 proprietor engages in conduct that contravenes an improvement
10 notice served on the proprietor.

11 Maximum penalty: 100 penalty units.

12 (2) The proprietor of a food business commits an offence if the
13 proprietor engages in conduct that contravenes a prohibition order
14 served on the proprietor.

15 Maximum penalty: 400 penalty units.

19 (1) A person commits an offence if—

20 (a) the person conducts a food business that is registered under this
21 part; and

22 (b) the person fails to display a current certificate of registration
23 for the food business on the business's premises.

24 Maximum penalty: 50 penalty units.

25 (2) An offence against this section is a strict liability offence.

1 (3) In this section:

2 *display*, of a certificate on business premises, means show in a way
3 that is clearly visible to a member of the public who enters the
4 premises in the ordinary course of business.

8 **116 Definitions—pt 9A**

9 In this part:

10 *approved food safety training course* means a food safety training
11 course—

- 12 (a) provided by a registered training organisation; and
13 (b) approved by the chief health officer in accordance with the
14 food safety training approval guidelines.

15 *food safety supervisor*, for a registered food business, means a
16 person who—

- 17 (a) holds a statement of attainment for an approved food safety
18 training course; and
19 (b) satisfies any requirement under this Act about eligibility to
20 become or remain a food safety supervisor; and

21 *Note* A reference to this Act includes a reference to a statutory
22 instrument made or in force under this Act (see Legislation Act,
23 s 104).

- 24 (c) as part of the person's formal duties in the business is—
25 (i) responsible for recognising, preventing and alleviating
26 food safety hazards in the business; and

- 1 (ii) authorised to supervise and give directions about food
2 safety to any person who handles food in the course of
3 the business; and
- 4 (d) is not also the food safety supervisor for—
- 5 (i) any other registered food business; or
- 6 (ii) if the registered food business has more than 1 site where
7 the handling or sale of food happens—more than 1 site
8 for the business.

9 *food safety training approval guidelines* means the guidelines made
10 by the chief health officer under section 119.

11 *food safety training course* means a training course about ways to
12 recognise, prevent and alleviate food safety hazards in food handled
13 or sold in a registered food business.

14 *registered training organisation*—see the *Training and Tertiary*
15 *Education Act 2003*, dictionary.

16 *statement of attainment*, held by a person, means a document issued
17 to the person by a training organisation certifying that the person has
18 satisfactorily completed a course conducted by the organisation.

19 **117 Registered food business must appoint food safety**
20 **supervisor**

- 21 (1) The proprietor of a registered food business commits an offence if—
- 22 (a) the proprietor fails to ensure that there is a food safety
23 supervisor for the business within 30 days after the day the
24 business is registered (the *establishment period*); or
- 25 (b) the business does not have a food safety supervisor at any time
26 after the end of the establishment period.

27 Maximum penalty: 50 penalty units.

- 1 (2) Subsection (1) (b) does not apply if it is less than 30 days since the
2 last day the business had a food safety supervisor.

3 *Note* The defendant has an evidential burden in relation to the matters
4 mentioned in s (2) (see Criminal Code, s 58).

5 **118 Proprietor of registered food business may be food**
6 **safety supervisor**

7 A proprietor of a registered food business may be the food safety
8 supervisor for the business.

9 **119 Food safety training approval guidelines**

10 (1) The chief health officer must make guidelines for the approval of a
11 food safety training course under this part.

12 (2) A guideline may apply, adopt or incorporate a law of another
13 jurisdiction or an instrument as in force from time to time.

14 (3) The Legislation Act, section 47 (6) does not apply to a law of
15 another jurisdiction or an instrument mentioned in subsection (2).

16 *Note* A law of another jurisdiction, or an instrument, applied, adopted or
17 incorporated by a guideline does not need to be notified under the
18 Legislation Act because s 47 (6) does not apply (see Legislation Act,
19 s 47 (7)).

20 (4) A guideline is a notifiable instrument.

21 *Note* A notifiable instrument must be notified under the Legislation Act.

16 Knowingly handling food in unsafe way

A person commits an offence if—

- (a) the person handles food intended for sale in a way that will, or is likely to, make the food unsafe; and
- (b) the person knows that handling the food in that way will, or is likely to, make the food unsafe.

Maximum penalty: 1 000 penalty units, imprisonment for 2 years or both.

17 Knowingly selling unsafe food

A person commits an offence if—

- (a) the person sells food; and

- 1 (b) the person knows the food is unsafe.
2 Maximum penalty: 1 000 penalty units, imprisonment for 2 years or
3 both.

4 **18 Knowingly describing food falsely**

- 5 (1) A person commits an offence if—
6 (a) the person falsely describes food intended for sale; and
7 (b) the person knows that a consumer of the food who relies on the
8 description will, or is likely to, suffer physical harm.

9 Maximum penalty: 1 000 penalty units, imprisonment for 2 years or
10 both.

11 *Note* For examples of food that is falsely described, see s 15.

- 12 (2) A person commits an offence if—
13 (a) the person sells food; and
14 (b) the person knows that—
15 (i) the food is falsely described; and
16 (ii) a consumer of the food who relies on the description will,
17 or is likely to, suffer physical harm.

18 Maximum penalty: 1 000 penalty units, imprisonment for 2 years or
19 both.

- 1 **19** **Negligently handling food in unsafe way**
- 2 A person commits an offence if—
- 3 (a) the person handles food intended for sale in a way that is likely
- 4 to make the food unsafe; and
- 5 (b) the person is negligent about whether handling the food in that
- 6 way is likely to make the food unsafe.
- 7 Maximum penalty: 750 penalty units.
- 8 **20** **Negligently selling unsafe food**
- 9 A person commits an offence if—
- 10 (a) the person sells food that is unsafe; and
- 11 (b) the person is negligent about whether the food is unsafe.
- 12 Maximum penalty: 750 penalty units.
- 13 **21** **Negligently describing food falsely**
- 14 (1) A person commits an offence if—
- 15 (a) the person falsely describes food intended for sale; and
- 16 (b) the person is negligent about whether a consumer of the food
- 17 who relies on the description, will or is likely to, suffer
- 18 physical harm.
- 19 Maximum penalty: 750 penalty units.
- 20 *Note* For examples of food that is falsely described, see s 15.
- 21 (2) A person commits an offence if—
- 22 (a) the person sells food; and
- 23 (b) the person is negligent about whether—
- 24 (i) the food is falsely described; and

- 1 (ii) a consumer of the food who relies on the description will,
2 or is likely to, suffer physical harm.

3 Maximum penalty: 750 penalty units.

4 **22 Handling and sale of unsafe food**

- 5 (1) A person commits an offence if the person handles food intended for
6 sale in a way that will, or is likely to, make the food unsafe.

7 Maximum penalty: 500 penalty units.

- 8 (2) A person commits an offence if the person sells food that is unsafe.

9 Maximum penalty: 500 penalty units.

- 10 (3) An offence against this section is a strict liability offence.

11 **23 Handling and sale of unsuitable food**

- 12 (1) A person commits an offence if the person handles food intended for
13 sale in a way that will, or is likely to, make the food unsuitable.

14 Maximum penalty: 400 penalty units.

- 15 (2) A person commits an offence if the person sells food that is
16 unsuitable.

17 Maximum penalty: 400 penalty units.

- 18 (3) For this section, it is immaterial whether the food is safe.

- 19 (4) An offence against this section is a strict liability offence.

20 **24 Misleading conduct relating to sale of food**

- 21 (1) A person commits an offence if the person, when conducting a food
22 business, engages in conduct that is misleading or deceptive or is
23 likely to mislead or deceive in relation to—

- 24 (a) the advertising, packaging or labelling of food intended for
25 sale; or

- 1 (b) the sale of food.
- 2 Maximum penalty: 500 penalty units.
- 3 (2) A person commits an offence if the person, to sell food or promote
4 the sale of food when conducting a food business, advertises,
5 packages or labels food in a way that falsely describes the food.
- 6 Maximum penalty: 500 penalty units.
- 7 *Note* For examples of food that is falsely described, see s 15.
- 8 (3) A person commits an offence if the person, when conducting a food
9 business, sells food that is packaged or labelled in a way that falsely
10 describes the food.
- 11 Maximum penalty: 500 penalty units.
- 12 (4) An offence against this section is a strict liability offence.
- 13 **25 Sale of food not complying with purchaser's demand**
- 14 (1) A person commits an offence if the person, when conducting a food
15 business—
- 16 (a) sells food to a purchaser; and
- 17 (b) the food is not of the nature or substance demanded by the
18 purchaser.
- 19 Maximum penalty: 500 penalty units.
- 20 (2) For this section, it is immaterial whether the food is safe.
- 21 (3) An offence against this section is a strict liability offence.
- 22 **26 Sale of unfit equipment or packaging or labelling material**
- 23 (1) A person commits an offence if—
- 24 (a) the person sells equipment (the *equipment sold*); and
- 25 (b) the person knows the equipment sold is, or is likely, to be used
26 for the handling of food; and

- 1 (c) the equipment sold, if used for a purpose for which it was
2 designed or intended to be used would, or would be likely to—
3 (i) make food unsafe; or
4 (ii) put other equipment in a condition that, if the other
5 equipment were used for a purpose for which it was
6 designed or intended to be used, would, or would be
7 likely to, make food unsafe.

8 Maximum penalty: 500 penalty units.

- 9 (2) Strict liability applies to subsection (1) (a) and (c).
10 (3) Subsection (1) does not apply if the equipment sold was not
11 designed for use in relation to the handling of food.

12 *Note* The defendant has an evidential burden in relation to the matters
13 mentioned in s (3) (see Criminal Code, s 58).

- 14 (4) A person commits an offence if—
15 (a) the person sells packaging or labelling material; and
16 (b) the person knows the material is, or is likely, to be used for the
17 handling of food; and
18 (c) the material, if used for a purpose for which it was designed or
19 intended to be used, would, or would be likely to, make food
20 unsafe.

21 Maximum penalty: 500 penalty units.

- 22 (5) Strict liability applies to subsection (4) (a) and (c).
23 (6) Subsection (4) does not apply if the packaging or labelling
24 material was not designed for use in relation to the handling of
25 food.

26 *Note* The defendant has an evidential burden in relation to the matters
27 mentioned in s (6) (see Criminal Code, s 58).

- 1 **27 Compliance with food standards code**
- 2 (1) A person commits an offence if the person contravenes a
- 3 requirement of the food standards code in relation to—
- 4 (a) the conduct of a food business; or
- 5 (b) food intended for sale; or
- 6 (c) food for sale.
- 7 Maximum penalty: 500 penalty units.
- 8 (2) A person commits an offence if—
- 9 (a) the person sells food; and
- 10 (b) the food does not comply with a requirement of the food
- 11 standards code for the food.
- 12 Maximum penalty: 500 penalty units.
- 13 (3) A person commits an offence if—
- 14 (a) the person sells or advertises food; and
- 15 (b) the food is packaged or labelled in a way that contravenes the
- 16 food standards code.
- 17 Maximum penalty: 500 penalty units.
- 18 (4) A person commits an offence if the person sells food, or advertises
- 19 food for sale, in a way that contravenes the food standards code.
- 20 Maximum penalty: 500 penalty units.
- 21 (5) An offence against this section is a strict liability offence.

1 **[1.5] Sections 28 and 29**

3 **28 Defence relating to publication of advertisements**

4 (1) This section applies to a prosecution for an offence, relating to the
5 publication of an advertisement, against—

- 6 (a) section 18 (Knowingly describing food falsely); or
7 (b) section 21 (Negligently describing food falsely); or
8 (c) section 24 (Misleading conduct relating to sale of food); or
9 (d) section 27 (3) or (4) (Compliance with food standards code).

10 (2) It is not an offence if the defendant—

- 11 (a) conducted a business concerned mainly with the publication of
12 advertisements; and
13 (b) published or arranged for the publication of the advertisement
14 in the ordinary course of the business.

15 *Note* The defendant has an evidential burden in relation to the matters
16 mentioned in s (2) (see Criminal Code, s 58).

17 (3) However, subsection (2) does not apply if the defendant—

- 18 (a) should reasonably have known that the publication of the
19 advertisement was an offence; or
20 (b) had previously been told in writing by an authorised officer
21 that publication of such an advertisement would be an offence;
22 or
23 (c) is the proprietor of a food business or is otherwise engaged in
24 the conduct of a food business for which the advertisement was
25 published.

- 1 **29** **Defence relating to food for export**
- 2 (1) This section applies to a prosecution for an offence against this part
- 3 if the offence involves contravention of a provision about food in
- 4 the food standards code.
- 5 (2) It is not an offence if—
- 6 (a) the food is to be exported to another country; and
- 7 (b) the food complies with the laws (the *foreign laws*) in force at
- 8 the time of the offence in the place to which the food is to be
- 9 exported; and
- 10 (c) the foreign laws deal with the same subject matter as the
- 11 provision of the food standards code.
- 12 *Note* The defendant has an evidential burden in relation to the matters
- 13 mentioned in s (2) (see Criminal Code, s 58).
- 14 (3) However, subsection (2) does not apply to food originally intended
- 15 for export but sold in the ACT.

16 **[1.6] Section 31**

- 18 **31** **Defence in relation to handling food**
- 19 (1) This section applies to a prosecution for an offence against—
- 20 (a) section 16 (Knowingly handling food in unsafe way); or
- 21 (b) section 19 (Negligently handling food in unsafe way); or
- 22 (c) section 22 (1) (which is about handling food in a way that will,
- 23 or is likely to, make it unsafe); or
- 24 (d) section 23 (1) (which is about handling food in a way that will,
- 25 or is likely to, make it unsuitable).

1 (2) It is not an offence if the defendant caused the food to which the
2 offence relates to be destroyed or disposed of immediately after the
3 food was handled in the way that made it, or was likely to make it,
4 unsafe or unsuitable.

5 *Note* The defendant has an evidential burden in relation to the matters
6 mentioned in s (2) (see Criminal Code, s 58).

20 (1) A person commits an offence if the person engages in conduct that
21 contravenes a prohibition, direction, condition or requirement of an
22 emergency order applying to the person.

23 Maximum penalty: 500 penalty units.

24 (2) In this section:

25 *emergency order* includes an emergency order as affected by an
26 order of the Supreme Court under section 42 (Operation of
27 emergency orders).

[1.11] Section 51 (2)

- (2) A person commits an offence if the person fails to take reasonable steps to comply with a requirement made of the person under subsection (1) (n) or (o).

Maximum penalty: 50 penalty units.

Note The Legislation Act, s 170 and s171 deal with the application of the privilege against selfincrimination and client legal privilege.

- (2A) An offence against this section is a strict liability offence.

[1.12] Section 52 (7)

substitute

- (7) A person commits an offence if the person interferes with a seized thing, or anything containing a seized thing, to which access has been restricted under subsection (6).

Maximum penalty: 50 penalty units, imprisonment for 6 months or both.

Note An authorised officer may seize a thing in a public place under this section and this part applies to the thing seized, see s 51 (3) to (5).

- (8) Subsection (7) does not apply if the person has an authorised officer's approval to interfere with the thing.

[1.13] Section 53 (4)

substitute

- (4) The proprietor of a food business commits an offence if the proprietor contravenes a direction given to the proprietor under subsection (2).

Maximum penalty: 50 penalty units.
