A Bill for

An Act to provide a scheme for the lifetime care and support of people who have been catastrophically injured, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **Part 1 Preliminary**

2 **1 Name of Act**

3 This Act is the *Lifetime Care and Support (Catastrophic Injuries)*
4 *Act 2014*.

5 **2 Commencement**

6 This Act commences on 1 July 2014.

7 *Note* The naming and commencement provisions automatically commence on
8 the notification day (see [Legislation Act](#), s 75 (1)).

9 **3 Dictionary**

10 The dictionary at the end of this Act is part of this Act.

11 *Note 1* The dictionary at the end of this Act defines certain terms used in this
12 Act, and includes references (*signpost definitions*) to other terms
13 defined elsewhere.

14 For example, the signpost definition '*legal costs*—see the [Legal](#)
15 [Profession Act 2006](#), dictionary.' means that the term 'legal costs' is
16 defined in that dictionary and the definition applies to this Act.

17 *Note 2* A definition in the dictionary (including a signpost definition) applies to
18 the entire Act unless the definition, or another provision of the Act,
19 provides otherwise or the contrary intention otherwise appears (see
20 [Legislation Act](#), s 155 and s 156 (1)).

21 **4 Notes**

22 A note included in this Act is explanatory and is not part of this Act.

23 *Note* See the [Legislation Act](#), s 127 (1), (4) and (5) for the legal status of
24 notes.

5 Offences against Act—application of Criminal Code etc

Other legislation applies in relation to offences against this Act.

Note 1 Criminal Code

The [Criminal Code](#), ch 2 applies to all offences against this Act (see Code, pt 2.1).

The chapter sets out the general principles of criminal responsibility (including burdens of proof and general defences), and defines terms used for offences to which the Code applies (eg *conduct*, *intention*, *recklessness* and *strict liability*).

Note 2 Penalty units

The [Legislation Act](#), s 133 deals with the meaning of offence penalties that are expressed in penalty units.

6 Application of Act

(1) This Act applies only in relation to a motor accident injury suffered by a person—

(a) as a result of a motor accident that happens in the ACT on or after 1 July 2014; and

(b) whether or not the person was at fault in the motor accident; and

(c) if at least 1 motor vehicle involved in the motor accident had CTP cover under the CTP Act at the time of the motor accident.

(2) A regulation may make provision for or in relation to limiting the application of this Act to a stated class of people.

Note 1 A reference to an Act includes a reference to a provision of an Act (see [Legislation Act](#), s 7 (3)).

Note 2 Power to make a statutory instrument (including a regulation) includes power to make different provision in relation to different matters or different classes of matters, and to make an instrument that applies differently by reference to stated exceptions or factors (see [Legislation Act](#), s 48).

- 1 (3) For subsection (1), a motor vehicle involved in a motor accident is
2 taken to have had CTP cover under the CTP Act at the time of the
3 motor accident if—
- 4 (a) a CTP policy was in force for the motor vehicle at that time; or
- 5 (b) the motor vehicle was owned by the Commonwealth, or an
6 entity representing the Commonwealth at that time; or
- 7 (c) there is a right of action against the nominal defendant under
8 the CTP Act in relation to the motor accident; or
- 9 (d) there would be a right of action against the nominal defendant
10 under the CTP Act in relation to the motor accident if the cause
11 of the motor accident was the fault of the responsible person or
12 driver of the motor vehicle in the use or operation of the motor
13 vehicle.

1 **Part 2** **Purpose and important concepts**

2 **7** **Purpose of Act**

3 The purpose of this Act is to—

4 (a) provide an indemnity insurance scheme to respond to the
5 reasonable and necessary treatment and care needs of people
6 who have been catastrophically injured in a motor accident;
7 and

8 (b) ensure that the scheme is fully funded.

9 **8** **Terms used in CTP Act**

10 A term used in the CTP Act has the same meaning in this Act.

11 *Note 1* A definition in an Act applies except so far as the contrary intention
12 appears (see [Legislation Act](#), s 155).

13 *Note 2* **CTP Act**—see the dictionary.

14 **9** **Meaning of *treatment and care needs* etc**

15 In this Act:

16 ***excluded treatment and care*** means treatment, care, support or
17 services of a kind prescribed by regulation for this definition.

18 ***treatment and care needs***, of a participant in the LTCS scheme—

19 (a) means the participant's needs in relation to any of the
20 following:

21 (i) medical treatment (including pharmaceutical treatment);

22 (ii) dental treatment;

23 (iii) rehabilitation;

24 (iv) ambulance transportation;

25 (v) respite care;

Part 2 Purpose and important concepts

Section 9

- 1 (vi) attendant care services;
- 2 (vii) aids and appliances;
- 3 (viii) prostheses;
- 4 (ix) education and vocational training;
- 5 (x) home and transport modification;
- 6 (xi) workplace and educational facility modifications;
- 7 (xii) any other kinds of treatment, care, support or services
- 8 prescribed by regulation; but
- 9 (b) does not include excluded treatment and care.

Part 3 LTCS commissioner

10 Appointment of LTCS commissioner

- (1) The Minister may appoint a public servant to be Lifetime Care and Support Commissioner of the Australian Capital Territory (the *LTCS commissioner*).

Note 1 For the making of appointments (including acting appointments), see the [Legislation Act](#), pt 19.3.

Note 2 In particular, an appointment may be made by naming a person or nominating the occupant of a position (see [Legislation Act](#), s 207).

- (2) The LTCS commissioner must be appointed for not longer than 3 years.

Note A person may be reappointed to a position if the person is eligible to be appointed to the position (see [Legislation Act](#), s 208 and dict, pt 1, def *appoint*).

11 Functions of LTCS commissioner

- (1) The LTCS commissioner has the following functions:

- (a) to monitor the operation of the LTCS scheme and, in particular, to conduct research into and collect statistics in relation to the scheme's operation;

Note A reference to an Act includes a reference to the statutory instruments made or in force under the Act, including any regulation (see [Legislation Act](#), s 104).

- (b) to advise the Minister about the administration, efficiency and effectiveness of the LTCS scheme;

- (c) to publicise and distribute information about the LTCS scheme;

- (d) to issue and monitor the LTCS guidelines;

- (e) any other function given to the LTCS commissioner under this Act or another territory law.

1 (2) The LTCS commissioner has the following functions in relation to
2 the provision of care, treatment, rehabilitation, long-term support
3 and other services for people who have sustained motor accident
4 injuries:

5 (a) to monitor those services;

6 (b) to support and fund programs that will improve delivery of
7 those services;

8 (c) to support and fund research and education in relation to the
9 delivery of those services.

10 **12 Delegation by LTCS commissioner**

11 (1) The LTCS commissioner may delegate the LTCS commissioner's
12 functions under section 11 to an authorised person.

13 (2) A delegate may subdelegate to an authorised person a function
14 delegated under subsection (1) if the subdelegation is authorised in
15 writing by the LTCS commissioner.

16 (3) In this section:

17 *authorised person* means—

18 (a) a public employee; or

19 (b) a person prescribed by regulation.

20 *Note* **Public employee**—see the [Legislation Act](#), dictionary, pt 1.

21 **13 LTCS commissioner staff**

22 The staff assisting the LTCS commissioner must be employed under
23 the [Public Sector Management Act 1994](#).

24 **14 Use of consultants and contractors**

25 The LTCS commissioner may engage the consultants and
26 contractors that may be necessary or convenient to exercise the
27 LTCS commissioner's functions.

Part 4 Participation in LTCS scheme

15 Participation in LTCS scheme—eligibility

(1) A person who has a motor accident injury to which this Act applies (the *injured person*) is eligible to participate in the LTCS scheme in relation to the injury if—

(a) the injury involves—

(i) a spinal cord injury; or

(ii) a brain injury; or

(iii) an amputation of a limb; or

(iv) burns; or

(v) permanent blindness; or

(vi) any other injury mentioned in the LTCS guidelines; and

(b) the injury satisfies the criteria mentioned in the LTCS guidelines.

Note 1 See s 6 for application of this Act to motor accident injuries.

Note 2 The LTCS guidelines are made under s 93.

(2) The person may participate in the LTCS scheme as an interim participant or lifetime participant.

Note 1 See s 20 for eligibility criteria for interim participants.

Note 2 See s 21 for eligibility criteria for lifetime participants.

- 1 (3) However, the person is not eligible to participate in the LTCS
2 scheme in relation to the motor accident injury if the person has
3 been awarded damages, under a final judgment entered by a court or
4 a binding settlement, for future economic loss in relation to the
5 person's treatment and care needs relating to the injury.

6 *Note 1* **Motor accident injury**, in relation to a person—see the dictionary.

7 *Note 2* **Treatment and care needs**, of a participant in the LTCS scheme—see
8 s 9.

- 9 (4) The LTCS guidelines may include further information in relation to
10 the person's eligibility to participate in the LTCS scheme,
11 including—

12 (a) the criteria to be satisfied in relation to a motor accident injury
13 for the person to be eligible to be a participant in the scheme;
14 and

15 (b) determining whether the motor accident injury satisfies the
16 criteria.

17 **16 LTCS scheme—initial application to participate**

- 18 (1) This section applies if an injured person is eligible to participate in
19 the LTCS scheme.

- 20 (2) Any of the following people may apply to the LTCS commissioner
21 for the injured person to become a participant in the LTCS scheme
22 in relation to the motor accident injury:

23 (a) the injured person;

24 (b) someone else on the injured person's behalf;

25 **Examples—par (b)**

26 1 the injured person's parent

27 2 the injured person's spouse

28 *Note* An example is part of the Act, is not exhaustive and may extend,
29 but does not limit, the meaning of the provision in which it
30 appears (see [Legislation Act](#), s 126 and s 132).

(c) an insurer for a motor accident claim made by the injured person in relation to the injury.

Note 1 If a form is approved under s 98 for this provision, the form must be used.

Note 2 A fee may be determined under s 97 for this provision.

Note 3 **Motor accident claim**, for a motor accident—see the CTP Act, s 77.

(3) The application must be accompanied by a medical certificate.

Note If a form is approved under s 98 for this provision, the form must be used.

(4) However, the LTCS commissioner may waive the requirement for a medical certificate if satisfied that—

(a) a certificate is not needed to establish the injured person's eligibility to participate in the LTCS scheme; and

(b) there are exceptional circumstances justifying the waiver.

(5) The injured person's consent is not needed for the insurer to make the application.

(6) The CTP regulator may direct the insurer to apply for the injured person to become a participant in the LTCS scheme.

Note **CTP regulator**—see the CTP Act, s 14.

(7) The insurer must comply with the CTP regulator's direction.

(8) In this section:

insurer, for a claim made by an injured person in relation to the motor accident injury, means—

(a) if the injured person is a CTP insured person—the CTP insurer for the person; or

(b) if the injured person is not a CTP insured person—the nominal defendant.

Note **CTP insured person**—see the CTP Act, s 16.

- 1 **17 LTCS scheme—authorisation for LTCS commissioner to**
2 **obtain information**
- 3 The LTCS commissioner may require an applicant for participation
4 in the LTCS scheme to authorise the LTCS commissioner to obtain
5 information and documents relevant to the applicant's motor
6 accident injury from stated people.
- 7 **18 LTCS scheme—guidelines for applications**
- 8 The LTCS guidelines may make provision for applications for
9 participation in the LTCS scheme, including provision for—
- 10 (a) making and determining applications (including information to
11 be given with an application); and
- 12 (b) requiring an insurer to pay the costs of any assessment required
13 by the LTCS guidelines in relation to an application; and
- 14 (c) imposing restrictions on the time within which an application
15 can be made or requiring the making of an application to be
16 deferred until an injury has stabilised.
- 17 *Note* The LTCS guidelines are made under s 93.
- 18 **19 LTCS scheme—acceptance as participant**
- 19 (1) This section applies if the LTCS commissioner receives an
20 application under section 16 (LTCS scheme—initial application to
21 participate).
- 22 (2) If the LTCS commissioner is satisfied that the injured person is
23 eligible to be a participant in the LTCS scheme, the LTCS
24 commissioner must give the injured person written notice accepting
25 the person as an interim participant in the scheme.

1 **20 LTCS scheme—interim participation**

- 2 (1) This section applies if the LTCS commissioner accepts an injured
3 person as an interim participant in the LTCS scheme.
- 4 (2) The period of the injured person's interim participation is—
- 5 (a) for an injured person who is 3 years or older—2 years, starting
6 on the date of the LTCS commissioner's determination; and
- 7 (b) for an injured person who is under 3 years—the period starting
8 on the date of the LTCS commissioner's determination and
9 ending on the injured person's 5th birthday.
- 10 (3) An injured person must not be accepted as an interim participant
11 more than once in relation to the same motor accident injury.
- 12 (4) The end of a period of interim participation in the LTCS scheme
13 does not prevent an injured person being later accepted as a lifetime
14 participant in the scheme.
- 15 (5) However, if the injured person is awarded damages, under a final
16 judgment entered by a court or a binding settlement, for future
17 economic loss in relation to the injured person's treatment and care
18 needs relating to the injury during or after the end of a period of
19 interim participation, the injured person must not be accepted as a
20 lifetime participant.

21 *Note Treatment and care needs*, of a participant in the LTCS scheme—see
22 s 9.

23 **21 LTCS scheme—application for lifetime participation**

- 24 (1) This section applies if an injured person is or has been an interim
25 participant in the LTCS scheme.
- 26 (2) Any of the following people may apply to the LTCS commissioner
27 for the injured person to become a lifetime participant in the LTCS
28 scheme:
- 29 (a) the injured person;

- 1 (b) someone else on the injured person's behalf;
- 2 **Examples—par (b)**
- 3 1 the injured person's parent
- 4 2 the injured person's spouse
- 5 *Note* An example is part of the Act, is not exhaustive and may extend,
- 6 but does not limit, the meaning of the provision in which it
- 7 appears (see [Legislation Act](#), s 126 and s 132).
- 8 (c) an insurer for a motor accident claim made by the injured
- 9 person in relation to the injury.
- 10 *Note 1* If a form is approved under s 98 for this provision, the form must be
- 11 used.
- 12 *Note 2* A fee may be determined under s 97 for this provision.
- 13 *Note 3* **Motor accident claim**, for a motor accident—see the CTP Act, s 77.
- 14 (3) The application must be accompanied by a medical certificate and
- 15 any additional information requested under subsection (6).
- 16 *Note* If a form is approved under s 98 for this provision, the form must be
- 17 used.
- 18 (4) The medical certificate must be completed—
- 19 (a) not more than 2 months before the date that the application for
- 20 lifetime participation is made; or
- 21 (b) if the LTCS commissioner allows another time within which to
- 22 complete the medical certificate—within the time allowed.
- 23 (5) However, the LTCS commissioner may waive the requirement for a
- 24 medical certificate if satisfied that—
- 25 (a) a certificate is not needed to establish the injured person's
- 26 eligibility for lifetime participation; and
- 27 (b) there are exceptional circumstances justifying the waiver.

1 (6) The LTCS commissioner must notify the injured person and any
2 other interested party, in writing, of any additional information that
3 must accompany the application.

4 (7) If the injured person is accepted as a lifetime participant in the
5 LTCS scheme, the injured person—

6 (a) ceases to be an interim participant in the scheme; and

7 (b) is a lifetime participant in the scheme until the end of the
8 person's life.

9 **22 Effect of LTCS scheme on compensation claims etc**

10 (1) This Act does not limit or otherwise affect the application of the
11 CTP Act in relation to a motor accident injury of an injured person
12 who is, or is eligible to become, a participant in the LTCS scheme,
13 except as provided by that Act.

14 *Note CTP Act*—see the dictionary.

15 (2) While an injured person is an interim participant in the LTCS
16 scheme in relation to a motor accident injury, time does not run for
17 the CTP Act, section 146 to section 149 or a provision of the
18 [*Limitation Act 1985*](#) in relation to a cause of action on a claim for
19 damages—

20 (a) relating to the injury; or

21 (b) relating to any other injury suffered by the person as a result of
22 the motor accident.

1 **Part 5** **Treatment and care needs**
2 **assessment**

3 **23 Assessment of participant's treatment and care needs**

- 4 (1) The LTCS commissioner must assess the treatment and care needs
5 of a participant in the LTCS scheme for the motor accident injury in
6 relation to which the injured person is a participant in the scheme.

7 *Note* ***Treatment and care needs***, of a participant in the LTCS scheme—see
8 s 9.

- 9 (2) The assessment must determine the participant's treatment and care
10 needs that—

- 11 (a) are reasonable and necessary in the circumstances; and
12 (b) relate to the motor accident injury in relation to which the
13 person is a participant in the LTCS scheme.

- 14 (3) The assessment must be made in accordance with the LTCS
15 guidelines.

16 *Note* The LTCS guidelines are made under s 93.

- 17 (4) The LTCS commissioner must—

- 18 (a) certify in writing its assessment of the participant's treatment
19 and care needs; and
20 (b) include in the certificate its reasons for the findings on which
21 the assessment is based; and
22 (c) give a copy of the certificate to the participant.

24 Effect of assessment

- (1) The LTCS commissioner's assessment of a participant's treatment and care needs is final and binding for this Act and any court proceeding under this Act.

Note The LTCS commissioner is to revise its assessment if necessary to give effect to a decision by an assessor or review panel in relation to a dispute about the participant's treatment and care needs (see s 64).

- (2) The LTCS commissioner's assessment of a participant's treatment and care needs supersedes any earlier assessment by the commissioner of those needs.

25 LTCS commissioner not liable for legal costs for assessment

The LTCS commissioner is not liable for legal costs for legal services provided to a participant in the LTCS scheme in relation to an assessment of the participant's treatment and care needs.

Note **Legal costs**—see the dictionary.

Legal services—see the dictionary.

26 Co-operation of participant

A participant in the LTCS scheme must comply with any reasonable request made by the LTCS commissioner in relation to an assessment of the participant's treatment and care needs, including a request to undergo a medical or other examination by a health practitioner.

Note **Health practitioner**—see the [Legislation Act](#), dictionary, pt 1.

27 Treatment and care needs assessment—LTCS guidelines

- (1) The LTCS guidelines may make provision for and in relation to the assessment of the treatment and care needs of a participant in the LTCS scheme.

Note The LTCS guidelines are made under s 93.

- 1 (2) In particular, the LTCS guidelines may make provision for the
2 following:
- 3 (a) the procedures to be followed for the assessment;
- 4 (b) the intervals at which assessments are to be carried out;
- 5 (c) the methods and criteria to be used to determine the treatment
6 and care needs of participants in the LTCS scheme;
- 7 (d) the information participants must provide for or in relation to
8 assessments.
- 9 (3) An assessment of the treatment and care needs of a participant in the
10 LTCS scheme must be carried out in accordance with the LTCS
11 guidelines.

12 **28 Request for treatment and care needs assessment**

15 assessment of the participant's treatment and care needs.

19 *Note 3* The LTCS commissioner is not liable for any legal costs incurred by a
20 participant for legal services provided to the participant (see s 25).

22 when a person mentioned in subsection (1) may request the LTCS
23 commissioner to carry out an assessment of the participant's
24 treatment and care needs.

25 *Note 1* The LTCS guidelines are made under s 93.

26 *Note 2* ***Treatment and care needs***, of a participant in the LTCS scheme—see
27 s 9.

Part 6 Payments under LTCS scheme

29 Definitions

In this Act:

approved provider, of a service, means a person—

- (a) approved by the LTCS commissioner to provide the service; or
- (b) who is an approved provider for the *Motor Accidents (Lifetime Care and Support) Act 2006* (NSW).

assessed treatment and care needs, of a participant in the LTCS scheme, means the treatment and care needs assessed by the LTCS commissioner under section 23 (Assessment of participant's treatment and care needs).

30 Payment of participants assessed treatment and care needs

- (1) The LTCS commissioner must pay all the reasonable expenses (if any) incurred by or on behalf of an injured person in relation to the injured person's assessed treatment and care needs while the injured person is a participant in the LTCS scheme.

- (2) Expenses are not payable in relation to—

- (a) excluded treatment and care; or

Note ***Excluded treatment and care***—see s 9.

- (b) treatment and care that is not assessed treatment and care needs.

Note ***Treatment and care needs***, of a participant in the LTCS scheme—see s 9.

- (3) The LTCS commissioner may pay a participant's expenses (if any) in relation to the participant's assessed treatment and care needs—

- (a) when the expenses are incurred; or

- 1 (b) by giving the participant an amount to cover the expenses over
2 a stated period under a payment agreement with the participant.
- 3 (4) The LTCS commissioner may only pay a participant's expenses for
4 treatment and care services that the LTCS commissioner has
5 approved, unless the LTCS commissioner agrees otherwise.
- 6 (5) The LTCS guidelines may make provision for determining which of
7 an injured person's treatment and care—
8 (a) are reasonable and necessary in the circumstances; and
9 (b) relate to the motor accident injury in relation to which the
10 person is a participant in the LTCS scheme.
- 11 *Note* The LTCS guidelines are made under s 93.
- 12 (6) This section is subject to section 31.
- 13 (7) In this section:
- 14 *payment agreement*, between the LTCS commissioner and a
15 participant in the LTCS scheme, means an agreement the LTCS
16 commissioner has with the participant for the participant to pay the
17 expenses relating to the participant's assessed treatment and care
18 needs.

19 **31 Payment not required in certain circumstances**

- 20 (1) The LTCS commissioner is not required to make a payment in
21 relation to the following:
- 22 (a) treatment, care, support or services provided to a participant in
23 the LTCS scheme for which the participant has not paid and is
24 not liable to pay;
- 25 **Example**
26 nursing care provided by a spouse or parent on a gratuitous basis
- 27 *Note* An example is part of the Act, is not exhaustive and may extend,
28 but does not limit, the meaning of the provision in which it
29 appears (see [Legislation Act](#), s 126 and s 132).

- 1 (b) any treatment, care, support or services required to be provided
2 to a participant by an approved provider but is provided by a
3 person who is not, when the treatment, care, support or
4 services is given, an approved provider.
- 5 (2) However, the LTCS commissioner may elect to make a payment in
6 relation to treatment, care, support or services mentioned in
7 subsection (1) if the LTCS commissioner considers that special
8 circumstances exist that justify making the payment.
- 9 (3) The LTCS guidelines may make provision for working out whether
10 special circumstances exist that justify payment in relation to
11 treatment, care, support or services mentioned in subsection (1).
- 12 (4) To remove any doubt, this section applies even if the treatment,
13 care, support or services mentioned in subsection (1) are provided in
14 connection with the assessed treatment and care needs of the
15 participant.

16 **32 Approved providers**

- 17 (1) The following treatment, care, support or services (provided as part
18 of the assessed treatment and care needs of a participant in the
19 LTCS scheme) must be provided by an approved provider of the
20 treatment, care, support or services:
- 21 (a) attendant care services;
- 22 (b) any other treatment, care, support or services (other than the
23 services of a medical practitioner) identified in the LTCS
24 guidelines as treatment, care, support or services that must be
25 provided by an approved provider.
- 26 (2) The LTCS guidelines may make provision for the standards of
27 competency of approved providers.
- 28 *Note* The LTCS guidelines are made under s 93.

Division 7.1 Disputes about eligibility

33 Definitions—div 7.1

34 Dispute about eligibility

- (1) The following people may, by written notice to the LTCS commissioner, dispute whether a motor accident injury suffered by an injured person satisfies the criteria stated in this Act and the LTCS guidelines for eligibility to participate in the LTCS scheme:

- (a) the injured person or someone on the injured person's behalf;
- (b) the insurer for the injured person's motor accident claim.

Note 1 If a form is approved under s 98 for this provision, the form must be used.

Note 2 A fee may be determined under s 97 for this provision.

Note 3 **Motor accident claim**, for a motor accident—see the CTP Act, s 77.

Note 4 The LTCS guidelines are made under s 93.

- (2) The dispute must be referred to an eligibility assessment panel within 6 months after the date of the LTCS commissioner's decision under section 19 (LTCS scheme—acceptance as participant) about the injured person's eligibility to participate in the LTCS scheme.
- (3) The LTCS commissioner may allow a notice under subsection (1) to be given orally.

1 **35 Eligibility dispute—convening assessment panel**

2 If the LTCS commissioner receives notice of a dispute under
3 section 34 (1), the LTCS commissioner must convene a panel (an
4 *eligibility assessment panel*) of 3 eligibility assessors to determine
5 the dispute.

24 assessment panel's certificate to the injured person within 5 working
25 days after the day the LTCS commissioner receives the certificate.
- 26 (4) The eligibility assessment panel may correct an error in the
27 certificate that arises from a clerical mistake or accidental slip or
28 omission.

1 **38 Eligibility assessment panel—review of decision**

2 (1) The following people may apply to the LTCS commissioner for
3 review of a decision by an eligibility assessment panel under
4 section 37:

5 (a) the injured person to whom the decision relates, or someone on
6 the injured person's behalf;

7 (b) the insurer for the injured person's motor accident claim;

8 *Note **Motor accident claim**, for a motor accident—see the CTP Act,*
9 *s 77.*

10 (c) the LTCS commissioner.

11 *Note 1 If a form is approved under s 98 for this provision, the form must be*
12 *used.*

14 (2) An application for review of a decision under section 37 must be
15 made within 6 months after the date the decision was made.

16 (3) A decision under section 37 may be reviewed on the following

18 (a) a change in the injured person's condition that happened or
19 first became apparent after the dispute was referred for
20 decision by the eligibility assessment panel and that is capable
21 of having a material effect on the decision;

22 (b) additional relevant information about the injured person's
23 injury that was unavailable, or could not reasonably have been
24 obtained, before the dispute was referred for decision by the
25 eligibility assessment panel and that is capable of having a
26 material effect on the decision;

27 (c) the decision was not made in accordance with the LTCS
28 guidelines;

29 *Note The LTCS guidelines are made under s 93.*

- 1 (d) the decision is demonstrably incorrect in a material respect.

2 **39 Eligibility review panel**

- 3 (1) If the LTCS commissioner receives an application under
4 section 38 (1) for review of a decision, the LTCS commissioner
5 must convene a panel (an *eligibility review panel*) of 3 eligibility
6 assessors to review the decision.
- 7 (2) The eligibility review panel may include an eligibility assessor who

- 22 (4) The eligibility review panel may correct an error in the certificate
23 that arises from a clerical mistake or accidental slip or omission.

40 Decision under this division binding

- (1) This section applies to a decision by—
- (a) an eligibility assessment panel about whether a motor accident injury satisfies the criteria stated in the LTCS guidelines for eligibility for participation in the LTCS scheme; or
 - (b) if the eligibility assessment panel's decision is reviewed under section 39—an eligibility review panel about whether a motor accident injury satisfies the criteria stated in the LTCS guidelines for eligibility for participation in the LTCS scheme.

- (2) The decision is final and binding for this Act and any court proceeding under this Act.

41 LTCS commissioner liable for costs of assessment

- (1) The LTCS commissioner must pay the costs of a decision and a review of a decision under this division.

- costs*, of a decision or a review of a decision, include the necessary costs and expenses of travel and accommodation to attend a panel for the decision or review incurred by—
- (a) the injured person to whom the decision relates; and
 - (b) a parent or other carer accompanying the injured person.

42 LTCS commissioner not liable for legal costs for decision or review

The LTCS commissioner is not liable for legal costs for legal services provided to an injured person or an insurer in relation to—

- (a) a decision about a dispute under section 37 (Eligibility dispute—determination by assessment panel); or

- (b) a review of the panel's decision by an eligibility review panel under section 39 (Eligibility review panel).

Legal services—see the dictionary.

43 Procedures for disputes about eligibility—LTCS guidelines

- 23 (2) The interested person must give the notice within 6 months after the
24 day the decision was made.

4 section 47, the LTCS commissioner must refer the dispute to the

8 section 48, the principal claims assessor must convene a panel (the
9 *claims assessment panel*) of 3 claims assessors.
- 10 (2) The claims assessment panel must—
- 11 (a) determine the dispute; and
- 12 (b) give the LTCS commissioner and interested person a certificate
13 of its determination and reasons for the determination.
- 14 (3) The claims assessment panel may correct an error in the certificate
15 that arises from a clerical mistake or accidental slip or omission.
- 16 (4) The claims assessment panel’s determination is final and binding for
17 this Act and any court proceeding under this Act.
- 18 **50** **Dispute about motor accident injury—reasonable legal**
19 **costs**

21 dispute about an injury under section 49.
- 22 (2) The panel’s determination must include a determination of the
23 amount of the reasonable legal costs payable by the injured person
24 for legal services provided to the person in relation to the referral
25 and determination of the dispute.

27 *Legal services*—see the dictionary.

1 (3) The LTCS commissioner must pay the injured person's reasonable
2 legal costs.

3 (4) No other legal costs are payable by the LTCS commissioner for
4 legal services provided to the injured person in relation to the
5 dispute.

6 **51 Dispute about motor accident injury—maximum legal**
7 **costs**

8 (1) A regulation may prescribe the maximum legal costs for legal
9 services provided to an injured person in relation to the referral and
10 determination of a dispute under this division.

12 **Legal services**—see the dictionary.

13 (2) A legal practitioner who provided legal services to an injured person
14 in relation to a dispute under this division is not entitled to be paid
15 or recover an amount exceeding the maximum legal costs for the
16 services.

18 **52 Dispute about motor accident injury—legal costs not**
19 **payable**

20 (1) This section applies if a legal practitioner provided legal services to
21 an injured person in relation to a dispute under this division.

22 (2) The legal practitioner is not entitled to recover legal costs for a legal
23 service or matter that a court or costs assessor determines were
24 unreasonably incurred.

1 **53** **Inconsistency between Act and Legal Profession**
2 **Act 2006**

- 3 (1) This division prevails if there is an inconsistency between this
4 section and the *Legal Profession Act 2006*.

5 *Note* A reference to an Act includes a reference to the statutory instruments
6 made or in force under the Act, including any regulation (see
7 *Legislation Act*, s 104).

- 8 (2) An assessment under the *Legal Profession Act 2006* of legal costs
9 that are the subject of a regulation under this division must be made
10 in accordance with the regulation.

23 in accordance with the LTCS guidelines;

24 (c) the treatment and care assessor's determination is
25 demonstrably incorrect in a material respect.

62 Review by treatment and care review panel

- (1) If a determination (the *original determination*) by a treatment and care assessor is referred under section 61 to a treatment and care review panel for review, the LTCS commissioner must convene a panel (a *treatment and care review panel*) of 3 treatment and care assessors to review the determination.

9 care review panel.

Part 8 Communicating with injured person or LTCS participant

66 Contacting injured person or LTCS participant

(1) The LTCS commissioner or an insurer for an injured person's claim may contact the injured person directly (whether or not the injured person has legal representation) in the following circumstances:

- (a) to give the injured person information about the LTCS scheme, including how to apply to be a participant in the scheme, the expenses covered by the scheme and information about treatment and care the injured person may receive before the person's treatment and care needs are assessed;

- (a) if the participant has asked the LTCS commissioner or the insurer for the participant's claim to contact the participant directly;
- (b) to advise the participant of assessment, treatment and care appointments;
- (c) to discuss the participant's treatment and care needs;
- (d) to discuss a request made under the LTCS scheme in relation to the participant's treatment and care needs;
- (e) in response to a complaint by the participant.

- 1 (3) The LTCS commissioner may contact the hospital where a
2 participant is being cared for to discuss matters relating to the
3 participant's involvement in the LTCS scheme.

4 **67 Contacting participant's legal representative**

- 5 (1) This section applies if the LTCS commissioner or an insurer for a

7 (a) sends correspondence about the participant to the participant's
8 lawyer; and
9 (b) has had no response to the correspondence within 20 days after

7 commissioner to pay expenses at the rate mentioned in the

- 9 (a) the Health Minister;
- 10 (b) services providers or others acting on their behalf.
- 11 *Health Minister* means the Minister responsible for administering
12 the [Health Act 1993](#).
- 13 **69** **Bulk billing arrangements for hospital, ambulance and**
14 **other expenses**
- 15 (1) The LTCS commissioner may enter into bulk billing arrangements
16 in relation to the following:
- 17 (a) the payment of expenses incurred in relation to the treatment of
18 participants in the LTCS scheme at hospitals;
- 19 (b) the payment of expenses incurred in transporting participants
20 in the LTCS scheme by ambulance;
- 21 (c) the payment of other expenses incurred in relation to other
22 treatment for participants in the LTCS scheme.
- 23 (2) In this section:
- 24 *transport*, of participants in the LTCS scheme, includes transport of
25 people classified as participants in the scheme under a bulk billing
26 arrangement.

1 *treatment*, of participants in the LTCS scheme, includes treatment
2 of people classified as participants in the scheme under a bulk
3 billing arrangement.

4 **70 Payment of hospital, ambulance, medical and other**
5 **expenses not covered by bulk billing arrangement**

6 (1) This section applies to each payment mentioned in subsection (2) if
7 payment for the expenses to which the payment relates—

8 (a) has not been made; and

9 (b) is not required to be made under a bulk billing arrangement.

10 (2) For subsection (1), the payments are the following:

11 (a) payment for the treatment of participants in the LTCS scheme
12 at hospitals;

13 (b) payment for conveying participants in the LTCS scheme by
14 ambulance;

15 (c) payment for any medical or dental treatment of, or
16 rehabilitation services provided to, participants in the LTCS
17 scheme.

18 (3) The rate at which a payment mentioned in subsection (2) must be
19 made by the LTCS commissioner is as follows:

20 (a) for treatment at a public hospital—the rate determined by the
21 Minister for Health;

22 (b) for treatment or a service for which a maximum rate is fixed
23 under section 71—the maximum rate fixed under section 71;

24 (c) in any other case—at the rate reasonably appropriate to the
25 treatment or service, having regard to the customary charge
26 made in the community for the treatment or service.

27 (4) A determination under subsection (3) (a) is a notifiable instrument.

28 *Note* A notifiable instrument must be notified under the [Legislation Act](#).

- 1 (5) If the LTCS commissioner does not make a payment mentioned in
2 subsection (2), the body or person who provided the treatment or
3 service to which the payment relates may recover the payment from
4 the LTCS commissioner as a debt in a court of competent
5 jurisdiction or the ACAT.

6 **71 Maximum amount payable for certain treatment and**
7 **services**

- 8 (1) This section applies to a payment (a *LTCS-related payment*)
9 payable by the LTCS commissioner for the following treatment or
10 services given to a participant in the LTCS scheme:
- 11 (a) medical treatment;
12 (b) dental treatment;
13 (c) rehabilitation services;
14 (d) attendant care services.
- 15 (2) This section also applies to the payment payable to a private hospital
16 for any treatment at the hospital.
- 17 (3) However, this section does not apply to a payment for treatment or a
18 service mentioned in subsection (1) if—
- 19 (a) the treatment or service is given to the participant at a public
20 hospital (whether as an inpatient or outpatient); and
21 (b) the payment is payable to the public hospital, and not the
22 treatment or service provider.
- 23 (4) The Minister may determine the maximum amount the LTCS
24 commissioner is liable for in relation to a claim for a LTCS-related
25 payment.
- 26 (5) A determination under subsection (4) is a disallowable instrument.

27 *Note* A disallowable instrument must be notified, and presented to the
28 Legislative Assembly, under the [Legislation Act](#).

- 1 (6) A LTCS-related payment may be determined by reference to—
 - 2 (a) fees recommended by the Australian Medical Association or
 - 3 other health professional association; or
 - 4 (b) a schedule of fees.
- 5 (7) A regulation may prescribe the way in which the LTCS
- 6 commissioner must pay a LTCS-related payment.
- 7 (8) The LTCS guidelines may make provision for the maximum amount
- 8 payable for LTCS-related payments that are not determined by the
- 9 Minister.
- 10 *Note* The LTCS guidelines are made under s 93.

73 Meaning of *contribution period*—div 10.1

(1) For this division, a *contribution period*, for which a required fund contribution is determined, is a financial year or other period (not longer than 12 months) determined by the LTCS commissioner to be a contribution period for section 83 (Determination of amount to be contributed to fund).

(2) The LTCS commissioner—

(a) may determine a contribution period that overlaps with another contribution period; but

(b) must not determine successive contribution periods with gaps between the periods.

74 Lifetime Care and Support Fund

The Lifetime Care and Support Fund (the *LTCS fund*) is established.

1 **75 LTCS fund directorate**

2 The Treasurer must, under the *Financial Management Act 1996*,
3 dictionary, definition of *directorate*, paragraph (b), establish and
4 keep a directorate for the LTCS fund.

5 **76 LTCS fund banking accounts**

- 6 (1) The director-general must open and keep 1 or more banking
7 accounts (an *LTCS fund banking account*) solely for the
8 management of the LTCS fund.
- 9 (2) An LTCS fund banking account is a directorate banking account of
10 the LTCS fund directorate.

11 **77 Closure of LTCS fund banking accounts**

12 If an LTCS fund banking account is closed, any amount standing to
13 the credit of the account immediately before it is closed must be
14 paid into another LTCS fund banking account.

15 **78 Appropriation of certain amounts for LTCS fund**

16 The following amounts, whether paid before or after the
17 commencement of this Act, are appropriated for the purposes of the
18 LTCS fund:

- 19 (a) fund levies paid under this part in relation to the issue of CTP
20 policies;
- 21 *Note CTP policy*—see the CTP Act, s 18.
- 22 (b) the interest from time to time accruing from the investment of
23 the fund;
- 24 (c) money required to be paid into the fund under this Act or any
25 other Act;
- 26 (d) all other money received by the LTCS commissioner and not
27 otherwise appropriated.

- 1 **79** **Payments from LTCS fund banking accounts**
- 2 The following amounts only are to be paid out of the LTCS fund
- 3 banking account:
- 4 (a) all payments required to be made by the LTCS commissioner
- 5 under part 6 (Payments under LTCS scheme);
- 6 (b) the remuneration, allowances, office accommodation and other
- 7 associated costs of the LTCS commissioner and the
- 8 commissioner's staff;
- 9 (c) all payments required to meet expenditure incurred in relation
- 10 to the LTCS commissioner's functions, if money is not
- 11 otherwise provided for that purpose;
- 12 (d) all other money required by or under this Act or any other
- 13 territory law to be paid from the LTCS fund.
- 14 **80** **Investment of amounts in LTCS fund banking accounts**
- 15 (1) An amount in an LTCS fund banking account that is not
- 16 immediately needed for a purpose mentioned in section 79 may be
- 17 invested—
- 18 (a) in a way that is authorised by the *Financial Management*
- 19 *Act 1996*; or
- 20 (b) in any other way prescribed by the LTCS investment
- 21 guidelines.
- 22 (2) Transfers between the territory banking account and LTCS fund
- 23 banking accounts to facilitate investment may be made without
- 24 appropriation.
- 25 (3) Any repayment of amounts invested from an LTCS fund banking
- 26 account must be paid into an LTCS fund banking account.
- 27 (4) Interest received by the Territory for the investment of amounts
- 28 from an LTCS fund banking account must be paid into an LTCS
- 29 fund banking account.

- 1 (5) However, if an investment of an amount from an LTCS fund
2 banking account is made or managed by a directorate, the
3 directorate may deduct from the interest received by the Territory
4 for the investment a fee charged by the directorate for making or
5 managing the investment.
- 6 (6) A fee charged by a directorate under subsection (4) must not be
7 more than the costs and expenses incurred by the directorate in
8 making or managing the investment.
- 9 (7) Interest that is to be paid into an LTCS fund banking account under
10 subsection (3) may be paid into the account directly or through the
11 territory banking account.

12 **81 LTCS fund investment guidelines**

- 13 (1) The Treasurer may make guidelines (the *LTCS fund investment*
14 *guidelines*) prescribing how an amount in an LTCS banking account

23 (a) the amount paid as the levy; and
24 (b) any interest received on the investment of the amount, or any
25 part of it, under this division.
- 26 (2) Interest received by the Territory on an investment under this
27 division of an amount from an LTCS levy must be applied for the
28 purposes for which the amount invested was appropriated.

- 1 (3) However, if an investment of an amount from an LTCS levy is made
2 or managed by a directorate, the directorate may deduct from the
3 interest received by the Territory for the investment a fee charged by
4 the directorate for making or managing the investment.
- 5 (4) A fee charged by a directorate under subsection (3) must not be
6 more than the costs and expenses incurred by the directorate in
7 making or managing the investment.

8 **83 Determination of amount to be contributed to fund**

- 9 (1) Before the beginning of each contribution period, the LTCS
10 commissioner must determine the amount needed to be contributed
11 to the fund in the contribution period (the *required fund*
12 *contribution*)—
- 13 (a) to fully fund the present and likely future liabilities of the
14 LTCS commissioner under part 6 (Payments under LTCS
15 scheme) in relation to people who become participants in the
16 scheme because of motor accident injuries suffered during the
17 contribution period; and
- 18 (b) to meet the payments needed to be made from the fund (other
19 than payments under part 6) during the contribution period;
20 and
- 21 (c) to provide for any other matters the LTCS commissioner
22 should, in all the circumstances, prudently make provision for
23 in relation to liabilities under part 6.
- 24 (2) The amount needed to fully fund the present and likely future
25 liability of the LTCS commissioner under part 6 is an amount
26 sufficient to provide an amount of money that together with
27 anticipated investment income is equal to the best estimate of the
28 cost of meeting the liability (in inflated dollars) when the liability
29 becomes payable.

- 1 (3) The LTCS commissioner's determination of the required fund
2 contribution for a contribution period must be made in accordance
3 with the report of an independent actuary.

4 **84 Determination of LTCS levy**

- 5 (1) The LTCS commissioner must determine a levy (a *LTCS levy*) for a
6 contribution period.

- 7 (2) A determination under subsection (1) is a notifiable instrument.

8 *Note 1* A notifiable instrument must be notified, and presented to the
9 Legislative Assembly, under the [Legislation Act](#).

10 *Note 2* Power to make the determination includes power to amend or repeal the

- 12 (3) For subsection (1), the LTCS levy must be an amount that the LTCS
13 commissioner reasonably believes will result in the required fund
14 contribution for the contribution period being contributed to the
15 fund.

- 16 (4) The LTCS levy may be determined as any of the following:

17 (a) a fixed amount;

18 (b) a percentage of the premium payable for a CTP policy;

19 (c) a combination of a fixed amount and percentage of the
20 premium payable for a CTP policy.

- 21 (5) An LTCS levy may be determined to differ according to any
22 classification or other criteria for the determination of premiums for
23 CTP policies as provided for by the CTP premium guidelines.

24 *Note 1* Power to make a statutory instrument in relation to a matter includes
25 power to make provision in relation to a class of matter (see [Legislation](#)
26 [Act](#), s 48 (2)).

27 *Note 2* **CTP policy**—see the CTP Act, s 18.

28 **CTP premium guidelines**—see the CTP Act, s 39.

85 Contributions to fund by CTP policy holders

The required fund contribution for a contribution period must be made by payment to the LTCS commissioner of the LTCS levy by each person to whom a CTP policy is issued during the contribution period.

86 Cancellation of LTCS levy

The CTP Act, part 2.5 (Cancellation of CTP policies) applies in relation to an LTCS levy payable in relation to the issue of a CTP policy in the same way it applies to the premium payable for the CTP policy.

87 Refund of LTCS levy

- (1) This section applies if a CTP policy issued to a person is cancelled on the cancellation of the registration of the motor vehicle to which the policy relates.
- (2) The LTCS commissioner must refund to the person, on a proportionate basis, the LTCS levy paid in relation to the CTP policy.

Division 10.2 Recovery of lifetime care and support payments

88 **Meaning of *present value of treatment and care liabilities*—div 10.2**

In this division:

present value of the LTCS commissioner's treatment and care liabilities, in relation to a participant in the LTCS scheme, is worked out as follows:

$$A + B$$

1 **A** means the amount paid by the LTCS commissioner under part 6
2 (Payments under LTCS scheme) in relation to the participant's
3 treatment and care needs associated with the participant's motor
4 accident injury.

5 **B** means the present value of the amounts the LTCS commissioner
6 estimates will become payable by the LTCS commissioner in the
7 future under part 6 in relation to the participant's treatment and care
8 needs associated with participant's motor accident injury.

9 **89 Recovery of LTCS payments—entitlement**

- 10 (1) The LTCS commissioner is entitled to recover from the appropriate
11 person the present value of its treatment and care liabilities in
12 relation to a motor accident injury suffered by a participant in the
13 LTCS scheme if the injury is an injury to which the CTP Act,
14 chapter 4 (Motor accident claims) applies.

- 16 (2) However, if the participant's injury was the result partly of the
17 participant's contributory negligence, the amount the LTCS
18 commissioner is entitled to recover under this division is reduced in
19 proportion to the participant's share in the responsibility for the
20 injury.

- 21 (3) In this section:

22 ***appropriate person***, from whom the LTCS commissioner is entitled
23 to recover, means—

- 24 (a) if the motor vehicle was at the time of the motor accident
25 subject to coverage under a policy of compulsory third-party
26 personal injury insurance or a compulsory motor vehicle
27 accident compensation scheme under the law of a place other
28 than the ACT or under a law of the Commonwealth—the
29 insurer of that policy or the person liable under that scheme; or

- (b) in any other case—the responsible person for the motor vehicle at the time of the accident, or the driver of the vehicle, or both.

90 Recovery of LTCS payments from responsible person or driver

- (1) This section applies if the motor accident injury of a participant in the LTCS scheme is caused by a motor accident involving an uninsured motor vehicle.

Note **Uninsured motor vehicle**—see the CTP Act, s 60.

- (2) This section does not apply if, when the motor accident happened—
- (a) an unregistered vehicle permit was in force for the uninsured motor vehicle; or
- (b) the registration provisions did not apply to the uninsured motor vehicle because of the [Road Transport \(Vehicle Registration\) Regulation 2000](#), part 2.2 (Vehicles not subject to registration provisions); or
- (c) the uninsured motor vehicle was exempted from the operation of the CTP Act, section 17 (Offence—using uninsured motor vehicle on road or road related area) by regulation.
- (3) The LTCS commissioner may recover as a debt from the responsible person for the uninsured motor vehicle, or the driver of the uninsured motor vehicle, or both, the present value of its treatment and care liabilities in relation to the participant's motor accident injury.
- (4) It is a defence to a proceeding under this section against the responsible person for the uninsured motor vehicle if the responsible person proves that—
- (a) the motor vehicle was driven without the authority of the responsible person; or

(b) the responsible person believed on reasonable grounds that the motor vehicle was insured.

(5) It is a defence to a proceeding under this section against the driver of the uninsured motor vehicle if the driver proves that the driver believed on reasonable grounds that—

(a) the driver had the responsible person's consent to drive the motor vehicle; and

(b) the motor vehicle was insured.

91 Recovery of LTCS payments from other person

(1) This section applies if the motor accident injury of a participant in the LTCS scheme was caused by the fault of someone other than the responsible person for a motor vehicle involved in the motor accident or a driver of the vehicle.

(2) The LTCS commissioner may recover as a debt from the person a proportion of the present value of its treatment and care liabilities in relation to the participant's injury as corresponds to the person's share in the responsibility for the injury.

92 Recovery of LTCS payments—evidentiary certificate

(1) This section applies to a court proceeding under this division.

(2) A certificate that appears to be signed by or on behalf of the LTCS commissioner and states any matter relevant to the present value of the LTCS commissioner's treatment and care liabilities in relation to a motor accident injury of a participant in the LTCS scheme is evidence of the matter.

2 **93 LTCS guidelines**
