## Safer Families Levy Bill 2016

---

### A Bill for

An Act to amend the *Rates Act 2004*

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **1 Name of Act**

2 This Act is the *Safer Families Levy Act 2016*.

3 **2 Commencement**

4 This Act commences on the day after its notification day.

5 *Note* The naming and commencement provisions automatically commence on  
6 the notification day (see [Legislation Act](#), s 75 (1)).

7 **3 Legislation amended**

8 This Act amends the [Rates Act 2004](#).

9 **4 Schedule 1, new section 1.3**

11 **1.3 Safer families levy**

12 (1) Safer families levy is imposed for a parcel of rateable land that is  
13 residential or rural land.

14 (2) In this section:

15 *safer families levy* means the safer families levy determined under  
16 the [Taxation Administration Act](#), section 139.

17 **5 Schedule 1, new section 2.1B**

19 **2.1B Application of further provisions—safer families levy**

20 (1) This section applies to the following provisions (the *applied*  
21 *provisions*):

22 (a) section 18 (How may rates be paid?);

23 (b) section 19 (Payment of rates by instalments);

24 (c) part 7 (Deferral and rebates) other than section 63 (Rebates of  
25 rates—eligible person since 30 June 1997) and section 64  
26 (Rebate of rates—capped);

- 1 (d) any other provision prescribed by regulation.
- 2 (2) The applied provisions have effect as if—
- 3 (a) a reference to rates included a reference to the safer families
- 4 levy imposed under section 1.3; and
- 5 (b) any other necessary changes were made; and
- 6 (c) any changes prescribed by regulation were made.
- 7 (3) Sections 18 and 19, as applied by this section, are subject to part 5
- 8 (Unit subdivisions).

9 **6 Rebate of levy**

10 **Schedule 1, section 3.2 (5), definition of *levy***

11 *substitute*

12 *levy*, for a parcel for a year, means levy imposed under this schedule

13 for the parcel for the year (other than the safer families levy

14 imposed under section 1.3), and includes any levy deferred under a

15 deferral determination.
