## **A Bill for**

An Act to amend legislation about intensive corrections orders

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

**1      Part 1              Preliminary**

3              This Act is the *Crimes Legislation Amendment Act 2017*.

**4      2      Commencement**

5              This Act commences on the day after its notification day.
