DETERMINATION OF FEES
NO. 106 OF 1994

Under section 80C of the Co-operative Societies Act 1939 I:

1. **Revoke** the determination of fees made on 7 June 1993 notice of which was published in Australian Capital Territory Gazette No. 24 on 16 June 1993.
2. **Determine** that the fees payable for the purposes of the sections of the Act listed in Column 1 of the Schedule, for the matter set out in Column 2 of the Schedule opposite to and in relation to those sections, shall be the amounts listed in Column 3 of the Schedule opposite to and in relation to those sections.


