DETERMINATION OF FEES AND CHARGES
DETERMINATION NO. 69 OF 1994

Under section 12(1) of the Trade Measurement (Administration) Act 1991 I revoke Determination No. 70 of 1993 dated 22 June 1993 and published in the Australian Capital Territory Gazette No. S119 of 30 June 1993. I determine that the fees payable for the purposes of the provision of the trade measurement legislation set out in Column 1 of the attached Schedule shall be the amount appearing in or calculated in accordance with the formula set out in Column 2 of the attached Schedule.
