Nature of waste in respect of which licence under section 19 of the Act is sought Fee payable (in \$)

- (4) 10 megalitres or more but less than 50 megalitres - 3,830.00
- (5) 50 megalitres or more - 5,195.00

Where the discharge of waste is likely to take place on less than three consecutive days and not more than two events in a licence year:

- (1) less than 100 kilolitres per day - 225.00
- (2) 100 kilolitres per day or more but less than 1 megalitre per day - 260.00
- (3) 1 megalitre per day or more but less than 10 megalitres per day - 305.00
- (4) 10 megalitres per day or more but less than 50 megalitres per day - 561.00
- (5) 50 megalitres per day or more - 755.00
