DETERMINATION OF FEES AND CHARGES APPLICABLE IN THE  
SUPREME COURT

NO. 70 OF 1995

Under subsection 37(1) of the *Supreme Court Act 1933*, with effect from 1 July 1995, I REVOKE Determination No. 33 of 1994 and, with effect from 1 July 1995, I DETERMINE the fees and charges set out in the Schedule to this Determination to be the fees and charges payable under section 37A of that Act, subject to the provisions for the exemption and deferral of liability set out in the Schedule.

**EXEMPTION FROM LIABILITY FOR PAYMENT**

No fee for filing a document or fee for the service or execution of process is payable in relation to proceedings under the *Infants' Custody and Settlements Act 1956*, the *Birth (Equality of Status) Act 1988* or Part VIII of the *Legal Practitioners Act 1970*.

Note: other exemptions from the payment of fees are set out in section 37B of the Supreme Court Act.

**DEFERRAL OF LIABILITY FOR PAYMENT**

The Registrar of the Supreme Court may defer liability for the payment of a fee or charge for a function, facility or service, in whole or in part, for a period not in excess of 14 days if, in the Registrar's opinion, payment cannot be made at the time of the request for the function, facility or service but payment could be made within 14 days after the making of the request.
