DRIVERS' LICENCES

Under section 217A of the *Motor Traffic Act 1936* (the Act), I revoke Determination No. 116 of 1996 dated 19 June 1996 and notified in the Gazette No. S144 of 27 June 1996, and I determine that:

- (a) the fee payable in respect of the sections of the Act specified in the Schedule shall be the fee specified in the Schedule for that section; and
- (b) the fee payable for the purposes of Regulation 22 of the Motor Traffic Regulations made under the Act shall be the fee specified in the Schedule for that Regulation.


