**DETERMINATION NO. 129 OF 1997**


Under Section 9A of the *Roads and Public Places Act 1937*, I **REVOKE** Determination No 120 of 19 June 1996 published in the Australian Capital Territory Gazette, No S144 of 27 June 1996

I **DETERMINE** that:

- (a) the fee for the opening up or the breaking of the surface of a carriageway which has a surface of the type set out in Column 1 of Schedule 1 in relation to that type of surface, and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has a surface of the type set out in Column 1 of Schedule 2 shall be the amount set out in or ascertained in accordance with the formula in Column 2 of Schedule 2 in relation to that type of surface.

This instrument commences operation on 1 July 1997
