#### PARKING CHARGES

Under Section 217A of the *Motor Traffic Act 1936* (the Act) I revoke Determination No. 281 of 1996, dated 25 November 1996 and notified in the Gazette No. S318 of 3 December 1996.

I determine that the fees payable for the purposes of subsection 163C(2) of the Act for the issue of a parking voucher from a voucher machine located at the site specified in the Schedule shall be the amount specified in the Schedule in relation to that site

Under Section 163C(3) of the Act, I specify that, for the purposes of Subsection 163C(2) of the Act, the period in relation to a voucher machine located at a site specified in the Schedule shall be the period specified in the Schedule in relation to that site
