INSTRUMENT NO. 184 OF 1998

DETERMINATION OF REGISTRATION FEES

Under section 217A of the *Motor Traffic Act 1936* (the Act) I revoke Instrument No.180 dated 17 July 1998 and notified in the Gazette No. S177 of 24 July 1998 and I determine that:

- (a) the fee payable in respect of the sections of the Act specified in the Schedule shall be the fee specified in the Schedule for that section; and
- (b) the fee payable under section 12 of the Act in respect of the registration of a vehicle of a kind listed in Part 2 of the Schedule to the *Road Transport Charges (Australian Capital Territory) Act 1993* of the Commonwealth shall be the fee specified in the Schedule to the Commonwealth Act.

The new fees will apply from 1 September 1998, and come into force immediately for all vehicle registrations which are due to expire on or after 31 August 1998.
