COURSES AND AWARDS AMENDMENT STATUTE 1999

Citation

1. This Statute is the *Courses and Awards Amendment Statute 1999*.

Interpretation

2. In this Statute:

Principal Statute means the *Courses and Awards Statute 1995*.

Amendment of section 3 of the Principal Statute

3. Section 3 of the Principal Statute is amended as follows:
 - (a) after “Bachelor of Community Education”, insert “Bachelor of Community Education (Honours)”;
 - (b) after “Bachelor of Information Technology”, insert “Bachelor of Information Technology and English”;
 - (c) after “Master of Advertising and Public Relations”, insert “Master of Applied Psychology”;
 - (d) after “Master of International Business”, insert “Master of International Finance”;
 - (e) after “Master of Legal Studies”, insert “Master of Library and Information Management”.

Amendment of section 4 of the Principal Statute

4. Section 4 of the Principal Statute is amended as follows:
 - (a) after “Graduate Diploma in Applied Psychology”, insert “Graduate Diploma in Business Administration”;
 - (b) after “Graduate Diploma in International Business”, insert “Graduate Diploma in Languages”;
 - (c) after “Graduate Diploma in Midwifery”, insert “Graduate Diploma in Neonatal Nursing”;
 - (d) after “Graduate Diploma in Outdoor Recreation”, insert “Graduate Diploma in Paediatric and Child Health Nursing”;
 - (e) omit “Diploma of Applied Science”, substitute “Advanced Diploma in Business
Diploma of Applied Science”.

Amendment of section 5 of the Principal Statute

5. Section 5 of the Principal Statute is amended as follows:

- (a) after “Graduate Certificate in Accountancy”, insert
“Graduate Certificate in Business Administration”;
- (b) after “Graduate Certificate in Education”, insert
“Graduate Certificate in English for Professional Purposes”;
- (c) after “Graduate Certificate in Human Resource Development”,
insert
“Graduate Certificate in Information Access and Delivery”;
- (d) after “Graduate Certificate in Management Studies”, insert
“Graduate Certificate in Marketing”.

The foregoing Statute is made by Council under section 40 of the *University of Canberra Act 1989*.
