DETERMINATION OF FEES

INSTRUMENT NO. 295 OF 2000

I, **Michael John Moore**, Minister for Health and Community Care, pursuant to my powers under the *Public Health Act 1997* ('the Act') hereby determine that:

1. under Section 137 of the Act, the fees for the purposes of the Act shall be those set out in the Schedule (where the determined fee for the purposes of a particular provision of the Act specified in Column 1 of the Schedule, is the fee which is listed in Column 2 of the Schedule immediately opposite the reference to the particular provision of the Act); and
2. under Subsection 19(b) of the Act, charities and benevolent institutions are exempt from the requirement to pay fees for a public health risk activity registration for the operation of a cooling towers and warm water storage systems.
