### POUNDS ACT 1928

### REVOCATION AND DETERMINATION OF FEES

#### INSTRUMENT No. 145 OF 2001

1. Pursuant to section 7 of the *Pounds Act 1928* (the Act) I **REVOKE** the Determination No 170 of 2000 notified in Gazette No S20 of 8 June 2000 and I **DETERMINE** that the fees payable for the purposes of the Act shall be in accordance with the Schedule.
