Public Health Act 1997

INSTRUMENT NO. 188 OF 2001

DETERMINATION OF FEES

In accordance with the provisions of section 137 of the *Public Health Act 1997* ('the Act') I, Michael Moore, Minister for Health, Housing and Community Services

1. DETERMINE that the fees for the purposes of the Act will be those set out in the following Schedule (where the determined fee for the purposes of a particular provision of the Act specified in the left hand column of the Schedule, is the fee which is listed in the right hand column of the Schedule immediately opposite the reference to the particular provisions of the Act)

Subsection 29(f) Fee for an application for a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with less than 200 beds for one (1) year.	\$500.00
Subsection 29(f) Fee for an application for a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with less than 200 beds for three (3) years.	\$1500.00
Subsection 29(f) Fee for an application for a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with 200 or more beds for one (1) year.	\$1000.00
Subsection 29(f) Fee for an application for a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with 200 or more beds for three (3) years.	\$3000.00
Subsection 29(f) Fee for an application for a Public Health Risk Activity Licence for the operation of a non-accredited Health Care Facility for one (1) year.	\$750.00
Subsection 29(f) Fee for an application for a Public Health Risk Activity Licence for the operation of a Health Care Facility operated by a sole Dental Practitioner for one (1) year.	\$200.00
Subsection 33(2) Fee for the renewal of a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility for one (1) year.	\$500.00
Subsection 33(2) Fee for the renewal of a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with less than 200 beds for three (3) years.	\$1500.00
Subsection 33(2) Fee for the renewal of a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with 200 or more beds for one (1) year.	\$1000.00

Provision	Fee
Subsection 33(2) Fee for the renewal of a Public Health Risk Activity Licence for the operation of an accredited Health Care Facility with 200 or more beds for three (3) years.	\$3000.00
Subsection 33(2) Fee for the renewal of a Public Health Risk Activity Licence for the operation of a non-accredited Health Care Facility for one (1) year.	\$750.00
Subsection 33(2) Fee for the renewal of a Public Health Risk Activity Licence for the operation of a Health Care Facility operated by a sole Dental Practitioner for one (1) year.	\$200.00
