RACE AND SPORTS BOOKMAKING ACT 2001

DETERMINATION OF FEES

INSTRUMENT NO. 260 OF 2001

Pursuant to subsection 97(1) of the *Race and Sports Bookmaking Act 2001* (the Act) I determine that the fees stated below are not refundable and are payable to the ACT Gambling and Racing Commission.

1. This determination has effect from 7 September 2001.

Race Bookmaking licence

2. For the purposes of section 6 of the Act, at the time of applying for a Race Bookmaking licence the applicant is to pay the relevant fee as indicated below in respect of the application:

(i) licence application - \$150(ii) licence renewal application - \$50.

3. For the purposes of subsection 7(1) of the Act, at the time of the issue of the licence the applicant is to pay an amount of \$65 for each year, commencing 1 July, or part of a year for which the licence is issued.

Race Bookmaker's agent licence

4. For the purposes of section 12 of the Act, at the time of applying for a Race Bookmaker's agent licence the applicant is to pay the relevant fee as indicated below in respect of the application:

(i) licence application - \$150 (ii) licence renewal application - \$50.

- 5. For the purposes of section 12 of the Act, at the time of applying for a second or subsequent Race Bookmaker's agent licence in respect of a nominated person and the second or subsequent licence period is to expire no later than the nominated person's initial licence period, the applicant is to pay the relevant non-refundable fee as indicated below in respect of the application:
 - (i) licence application \$20 (ii) licence renewal application - \$20.
- 6. For the purposes of subsection 13(1) of the Act, at the time of the issue of the initial licence, the nominated person is to pay an amount of \$20 for each year, commencing 1 July, or part of a year for which the licence is issued. The fee does not apply to the issue of a second or subsequent licence.

Sports Bookmaking licence

- 7. For the purposes of subsection 25(1) of the Act, at the time of applying for a Sports Bookmaking licence, the applicant is to pay the relevant fee in respect of the application as indicated below:
 - a) if the applicant is an individual \$650.
 - b) if the applicant is a syndicate
 - (i) \$500; and
 - (ii) \$150 for each syndicate member.
 - c) if the applicant is a corporation
 - (i) \$500; and
 - (ii) \$150 for each director of the corporation.
- 8. For the purposes of subsection 25(5) of the Act, the applicant at the time of submitting an authorisation for a person mentioned in the notice, is to pay a fee of \$150.
- 9. For the purposes of subsection 25(1) of the Act, at the time of applying for the renewal of a Sports Bookmaking licence, the applicant is to pay the relevant fee in respect of the application as indicated below:
 - a) if the applicant is an individual \$50.
 - b) if the applicant is a syndicate \$50 in respect of each member of the syndicate.

- c) if the applicant is a corporation:
 - (i) \$50 in respect of each director of the corporation; and
 - (ii) \$50 in respect of a person mentioned in a notice given under subsection 25(5) if the relationship between the person and the corporation remains unchanged since the notice was given to the applicant.
- 10. For the purposes of section 26 of the Act, the entity to be issued with a Sports Bookmaking licence is to pay a licence fee as follows:
 - a) on the day on which the licence is issued:
 - (i) if the licence is granted on 15 July, an amount of \$10,000; or
 - (ii) if the licence is granted on a day other than 15 July, the proportion of \$10,000 that the number of days to 14 July next occurring bears to 365; and thereafter
 - b) by 15 July of each subsequent year, \$10,000 per annum.

Sports Bookmaker's agent licence

- 11. For the purposes of section 34 of the Act, at the time of applying for a Sports Bookmaker's agent licence the applicant is to pay the relevant fee as indicated below in respect of the application:
 - (i) licence application \$150(ii) licence renewal application \$50.
- 12. For the purposes of subsection 35(1) of the Act, at the time of the issue of the licence, the nominated person is to pay an amount of \$20 for each year, commencing 1 July, or part of a year for which the licence is issued.

Replacement of licences

13. For the purposes of section 44 of the Act, at the time the replacement licence is issued, the licensee is to pay \$20.
