## LAND (PLANNING AND ENVIRONMENT) ACT 1991

# DETERMINATION OF CRITERIA FOR EXEMPTION OF SIGNS FROM PART 6 OF THE LAND (PLANNING AND ENVIRONMENT) ACT 1991

### INSTRUMENT NO. 66 OF 2001

The Australian Capital Territory Executive, under subsection 282(2) of the Land (Planning and Environment) Act 1991 ("the Act") and Regulation 25 of the Land (Planning and Environment) Regulations, specifies criteria for the exemption of signs from the application of the provisions of Part 6 of the Act.

This instrument applies to the erection, fixing or display of a sign or advertising material on land, other than in accordance with a right to do so expressly given by a current licence granted under the Act, or a lease. It does not apply to signs located or proposed to be located on National Land.

Schedules 1 and 2 to this instrument set out categories of signs that are exempted from the operation of the provisions of Part 6 of the Act, subject to the criteria specified below.

### The criteria are:

1. Any sign referred to in the two attached schedules, and marked with an "E", is exempt from the operation of the provisions of Part 6 of the Act provided it complies with 'Part C3 – Sign Policies' of the Territory Plan.

- 2. Any sign referred to in the two attached schedules, and marked with a "T", is exempt from the operation of the provisions of Part 6 of the Act provided:
  - (a) the sign complies with 'Part C3 Sign Policies' of the Territory Plan; and
  - (b) the sign is not erected, fixed or displayed for more than two weeks in any calender year.
- 3. Any sign that is the subject of an approved Signage Master Plan in accordance with 'Part C3 Sign Policies' of the Territory Plan is exempt from the operation of the provisions of Part 6 of the Act.
