Pounds Act 1928, Section 39 – Determination of fees, charges and rates

1. Pursuant to section 39 of the *Pounds Act 1928* (the Act) I **REVOKE** the Determination No DI 2002 - 79 notified on the ACT Government Legislation Register and I **DETERMINE** that the fees payable for the purposes of the Act shall be in accordance with the Schedule.
