

# Road Transport (General) (Parking Permit Fees) Revocation and Determination 2003

## Disallowable Instrument DI 2003—108

made under the

***Road Transport (General) Act 1999*, section no 96 (Determination of fees, charges and other amounts).**

1. I **REVOKE** Instrument No. DI 2002 - 86, dated 20 June 2002 and notified on the ACT Government Legislative Register and I **DETERMINE** that the fee payable in respect of the provisions of the *Road Transport (Safety and Traffic Management) Regulations 2000* (the Regulations), made under the *Road Transport (Safety and Traffic Management) Act 1999*, specified in the Schedule shall be the fee specified in the Schedule for that provision.
2. The fees for services provided are specified in the Schedule hereunder in Column 2 and prices for 2003-2004 are specified in Column 4 opposite, in relation to that service.
3. Explanatory notes (including the previous year's fee) are included in the Schedule. Explanatory notes are included at the end of the Schedule, where applicable. Headings and explanatory notes in the Schedule do not form part of the determination. (For example: where new fees for 2003-04 are denoted by an "N/A" in 2002-03, if included in the schedule, would not form part of the determination).
4. The fees determined in this schedule are payable to the ACT Government by the person(s) requesting the goods or services, as listed.
5. This Instrument commences on 1 July 2003.
