I **REVOKE** Instrument No. DI 2002 - 88, dated 20 June 2002 and notified on the ACT Government Legislation Register and I **DETERMINE** that that the fee payable in respect of the provisions of the *Road Transport (Vehicle Registration) Regulations 2000* (the Regulations), made under the *Road Transport (Vehicle Registration) Act 1999*, specified in the attached Schedule shall be the fee specified in the Schedule for that provision.
