# Electoral Act 1992, s 8 (Determination of Fees)

- 1. The ACT Electoral Commission **REVOKES** disallowable instrument No. DI2004-159 (Electoral (Fees) Determination 2004).
- 2. The ACT Electoral Commission **DETERMINES** that the fees payable for the purposes of the Act are as set out in the Schedule.
- 3. The ACT Electoral Commission **DETERMINES** that fees are payable by persons or organisations receiving the goods or services specified in this determination.
- 4. The ACT Electoral Commission **DETERMINES** that fees are payable to the ACT Electoral Commission.
- 5. The ACT Electoral Commission **DETERMINES** that fees are payable after a service has been supplied, by the due date specified in the invoice for the service.
