

Road Transport (General) (Vehicle Registration and Related Fees) Determination 2005 (No 1)

Disallowable instrument DI2005 — 80

made under the

Road Transport (General) Act 1999, s 96 (Determination of fees, charges and other amounts)

1 Name of instrument

This instrument is the *Road Transport (Vehicle Registration and Related Fees) Determination 2005 (No1)*.

2 Revocation

I revoke instrument no DI2004-70, notified on 20 May 2004.

3 Registration fees – Part A

I determine that the registration fees in Part A of Schedule 1, column four, apply to renewal of registration where the effective start date of the new registration period is after 30 June 2005, even if the payment is made before 1 July 2005.

I also determine that the fees in Part A of Schedule 1, column three, are applicable to registrations or renewals of registration if the effective start date of the new registration period is on or before 30 June 2005.

4 Registration related fees – Part B

I determine that the fee payable for a matter described in this instrument, Schedule 1, Part B, in the 2nd column is the amount mentioned in column four for the matter after 30 June 2005.

I determine that the fee payable for a matter described in this instrument, Schedule 1, Part B, in the 2nd column is the amount mentioned in the column three for the matter on or before 30 June 2005.

5 Payment of Fee

A fee to which this determination applies is payable to the road transport authority by the applicant for registration or other matter to which the application relates.

6 Commencement

This instrument commences the day after notification on the ACT Legislation Register.

2. if the registration period is not an exact number of months, the amount calculated using the formula $A/365 \times N$ where A is 12-month registration fee and N is the number of days of the registration period;

plus any other fee specified in this schedule applicable to the registration e.g. surcharge for short-term registration (Item 46).
