### *Road Transport (General) Act 1999*, Section 96 - Determination of Fees, Charges and Other Amounts

#### 1. Name of instrument

This instrument is the Road Transport (General) (Fees) Determination 2005 (No 1).

#### 2. Revocation

I revoke the disallowable instrument number **DI 2004-186** as notified on the ACT Government Legislation Register.

#### 3. Determination of fees

The fees for services provided are specified in the Schedule hereunder in Column 2 and prices for 2005-2006 are specified in Column 4 opposite, in relation to that service. Where applicable, GST inclusive fees are marked with a double asterisk (\*\*).

- (i) subject to paragraph (ii), the fee payable in respect of the section of the *Road Transport (Dimensions and Mass) Act 1990* specified in the attached Schedule shall be the fee specified in the Schedule for that section; and
- (ii) where a vehicle is a vehicle of a kind referred to in Part 3 of the Schedule to the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth), the charges in that Schedule shall apply.
