

# Road Transport (General) (Driver Licence and Related Fees) Determination 2008 (No 1)

## Disallowable Instrument DI 2008 –105

made under the

***Road Transport (General) Act 1999, section 96 (Determination of fees, charges and other amounts)***

### **1. Name of instrument**

The name of this instrument is the Road Transport (General) (Driver Licence and Related Fees) Determination 2008 (No 1).

### **2. Commencement**

This instrument commences on the day after notification on the ACT Legislation Register.

### **3. Revocation of previous determination**

Disallowable instrument DI 2007-176 (Road Transport (General) (Driver Licence and Related Fees) Determination 2007 (No 1)) is revoked.

### **4. Determination of fees**

- (1) The fee payable for a matter listed in an item in column 2 of Part 1 of the Schedule which occurs on or before 30 June 2008 is the amount for that item in column 3.
- (2) The fee payable for a matter listed in an item in column 2 of Part 1 of the Schedule which occurs on or after 1 July 2008 is the amount for that item in column 4.
- (3) The fee for a full or provisional licence for a period other than those listed in Part 1 of the Schedule is determined in accordance with the formula set out in Part 2 of the Schedule.

### **5. Payment of fee**

A fee listed in the Schedule is payable to the Australian Capital Territory Road Transport Authority by the applicant for the licence or other matter to which the application relates.

### Part 2 – Formula For Short Term Licence Periods

The fee payable for:

- (a) a full licence issued or renewed for a period other than five years; or
- (b) a provisional licence issued or renewed for a period other than three years,

shall be calculated using the formula:

$$(F/60) \times N$$

Where:

**F** is the five-year fee for a full licence payable at the time of the application for the licence; and

**N** is the number of months for which the full or provisional licence is to be issued or renewed. Any part of a month shall be treated as one month.
