1. Name of instrument

The name of this instrument is the Road Transport (General) (Parking Permit Fees) Determination 2008 (No 1).

2. Commencement

This instrument commences the day after notification on the ACT Legislation Register.

3. Revocation of previous determination

Disallowable instrument DI 2007-178 (Road Transport (General) (Parking Permit Fees) Determination 2007 (No 1)) is revoked.

4. Determination of fees

- (1) The permit fee payable for a matter listed in an item in column 2 of the Schedule where the permit period commences on or before 30 June 2008 is the amount for that item in column 3.
- (2) The permit fee payable for a matter listed in an item in column 2 of the Schedule where the permit period commences on or after 1 July 2008 is the amount for that item in column 4.

5. Payment of fee

A fee listed in the Schedule is payable to the Territory by the applicant for the permit or other matter to which the application relates.
