## Major Events Security Declaration 2008 (No 2)\*

Disallowable instrument DI2008—59

made under the

*Major Events Security Act 2000*, s 4 (Declaration of major events)

---

1. Under section 4 of the *Major Events Security Act 2000* (the Act) the Olympic Torch Relay (specified in Schedule 1) at the venue (specified in Schedule 3) is a major event for the purposes of the Act.
2. This declaration is in force for the period commencing at 12.01 am on 24 April 2008 and concluding at 11.59 pm on 24 April 2008.
3. Under section 7 of the Act the statutory conditions of entry to the venue are stated to be as follows:
  - (a) a person seeking to enter or remain in the venue shall, if asked by a police officer, permit a search to be made of his or her personal property;
  - (b) a person seeking to enter or remain in the venue shall, if asked by a police officer, permit a frisk search to be made of his or her person; and
  - (c) a person shall not take into or possess in the venue a prohibited item.
4. For the purposes of this declaration:
  - (a) the description of the event is specified in Schedule 1;

### **1. Description of the event**

### **2. Times and dates of the event**

The proposed times and dates of the event:

- (i) Commencement of pre-launch program at 6.15am on 24 April 2008
- (ii) Commencement of official program at 8.30am on 24 April 2008
- (iii) Commencement of torch relay at 9.00am on 24 April 2008
- (iv) Torch relay route on 24 April 2008
- (v) Final community celebrations on 24 April 2008

## **Schedule 2 –**

Declaration made under s. 4 of the *Major Events Security Act 2000*

---

### **PROHIBITED ITEMS**

Glass items, other than optical lenses and items containing food or beverages for infants;

Cans, other than those containing food or beverages for infants;

Prohibited weapons and prohibited articles under the *Prohibited Weapons Act 1996*;

Knives, including knives under the *Crimes Act 1900*;

Firearms under the *Firearms Act 1996* excepting those carried lawfully by law enforcement officers performing duties at, or as part of the event;

Fire extinguishers and any other material contained within a receptacle that is likely to be used as a fire retardant except those lawfully in the possession of emergency services personnel;

Paint stored in any type of container (including balloons, tins and aerosol cans);

Flares, fireworks, explosives, smoke bombs, petrol and dangerous goods under the *Dangerous Substances Act 2004* excepting those fireworks authorized lawfully by those persons contracted to participate in formal proceedings relating to the event;  
Controlled drugs and plants under Schedules 1 & 2 of the *Criminal Code Regulations 2005* that includes prohibited substances, plants and drugs of dependence; and  
Balls, eggs, paint bombs and any similar item that is likely to be used as a projectile.





## **Beijing Olympics Torch Relay – Canberra, 24 April 2008**

### **Description of route/s and additional areas for Declaration under the *Major Events Security Act 2000***

The declaration will apply to the route of the Torch relay and includes the principal roads, adjacent roads up to the first intersection, and adjacent public open spaces.

All roads include the road related areas, as defined in the Australian Road Rules February 2008 version.

All public open spaces are defined by Section and, where appropriate, Block number.

The declaration does not apply to leased land.

## **Torch Relay – Declaration of the Route/Venue**

Section 57, Parkes bounded by King Edward Terrence and Parkes Place including Reconciliation Place and Commonwealth Place, but excluding Questacon (Section 57, Block 1)

Lake Burley Griffin, Central Basin (Section 54).

Commonwealth Park, Section 48 Parkes, including Rond Place.

Parkes Way from Kings Avenue to Commonwealth Avenue.

Coranderrk Street between Constitution Avenue and Parkes Way.

Commonwealth Avenue.

Coronation Drive between Commonwealth Avenue and Flynn Drive.
